News

DIVERS PRACTICE: The Divers have invited interested SARCI personnel to come to their practice on Sunday, March 1. It will be held at the lake at Kennedy Park, Noonish; meet at Ramada 29. It is a practice for qualified divers.

FOUR WHEEL DRIVE PROGRAM: Chuck McHugh will be the guest speaker. He plans to tell about the experiment that's been in progress since last summer on desert searches.

BASIC ORIENTATION AT THE FAIR: Basic Orientation will be held at the Pima County Fair on both weekends of the Fair, April 10 and 11 and April 17 and 18. This would be a good time for SARA trainees and applicants to get training cards filled in. Also, all trainees from all groups who need this Basic Orientation to get on call sheets should plan to attend. A TECHNICAL NOTE: As a result of soul searching in SARA and discussions with other technical groups and individuals, the decision has been made that body belays will no longer be considered adequate for rescue loads. The recent rescues and practices we have had at Milepost 10 on the Mt. Lemmon Highway have proven to many of us that new techniques are required for belaying a Stokes basket and crew. Recently, a mostly static load was measured using a Stokes, victim, and six people with packs on the slope at Milepost 10. With only concerted bouncing by the Stokes crew a load of 1,000 pounds was put on the haul anchor. Although this is far below the capability of the hauling system, no body belay could have held a true shock load in such a situation where loading could easily amount to more than twice the static weight of the Stokes and crew.

Techniques for better belaying are under development. Those in use now are parallel hauling and lowering systems with separate anchors and belays using a spring-loaded Gibbs ascender. Anyone with ideas should get in touch with Bob Buecher, Dave Brown, George Simons, or Gary Young. -- Gary Young.

Mirror Signaling Instructions

- 1. Reflect sunlight from mirror onto a nearby surface, raft, hand, tree, etc.
- 2. Slowly bring mirror up to eye level and look through sighting hole. You will see a bright light spot. This is the aim indicator.
- 3. Hold mirror close to the eye and slowly turn and manipulate it so that the bright light spot is on the target.
- 4. Even though no aircraft or ships are in sight, continue sweeping the horizon for mirror flashes may be seen for many miles -- even in hazy weather.

HAS YOUR FIRST AID CERTIFICATION EXPIRED? . . . The never-ending job of updating First Aid records has placed me in the position, again, of asking all personnel to contact me regarding their First Aid expiration dates. Thus far only 2% of the field qualified members have done so. As of May 1, 1981, all "callers" will be furnished with the names of persons no longer eligible for field operations due to expired First Aid (according to SARA's records). Therefore, as of May 1, 1981, if you suddenly stop receiving S & R calls you will know the probable reason. Please call 881-6775 (Between 7PM & 9PM) or check with me at any SARA meeting.

Receipts must include your name, mileage, and appropriate callout information. Reimbursable expenses include gasoline used during a callout and items lost, stolen or damaged. Items other than gasoline need a written description including age and how it was lost. Reimbursements are at the discretion of the Sheriff's Department, and ONLY AVAILABLE FOR SEARCHES AND/OR RESCUES.
