SARCI COUNCIL BRIEFS (2/17/82 MEETING)

Under Communications, it was reported that the Arizona State S&R was granted a license on 155.160. The Council is considering charging the groups \$3 per pager to cover the service contract on the maintenance of the pagers.

A vote on the By-Laws changes from 45 days down to 15 days failed because it did not get the necessary two-thirds vote.

Sun. Jan. 31	Limited rescue of a male hiker in Esperero Canyon. Subject had twisted his knee about a mile below Bridal Veil Falls. He was able to walk out escorted by volunteers.
Tues. Feb. 2	Full rescue of ten teenagers of Canyon Del Oro High School from an area near Old Baldy Saddle on Mt. Wrightstown. Subjects took the wrong trail down the mountain and were overdue.
