- 3/31/85 Evacuation of 10-yr-old with knee injury in Romero Canyon about 1 mile from the Pass. Stokes evacuation to helicopter.
- 4/06/85 Evidence search at 36th and Park. Cooperative and productive effort between foot troops, posse and Sheriff's Assist Team.
- 4/12-14/85 Evidence search at Wade and Artesiano. Most instructive working with detectives with immediate feedback on success.
- 4/14/85 Victim having diabetic siezure at Tanque Verde Ranch. Stabilized and assisted by friends, no need for further assistance.
- 4/14/85 Stokes evacuation from Romero Canyon for 14-yr-old boy with ankle injury.
- 4/15/85 Fall victim in Hutch's pool area. Fractured ankle (reduced in the field by medical personnel) and 3 fractures in pelvis. Rescue team spent remainder of night with victim until helicopter evacuation was possible by daylight.
