- 6/02/85 Overdue hikers in Marshall Gulch area. (21 people, 43 hrs)
- 6/08/85 Missing male on Mt. Bigelow. Found at home. (13 people, 23 hrs)
- 6/10/85 Missing elderly male near 6th and Los Reales, found deceased on West side of Santa Cruz. (14 people, 30 hrs)
- 6/11/85 Two overdue hikers in Marshall Gulch area, came out as search began. (17 persons, 23 hrs)
- 6/11/85 Extrication from car on backside of Mt. Lemmon. Completed by Forest Service and Mt. Lemmon Fire Dept.
- 6/15/85 Assist Cochise County in search of lost 9-yr-old in Scotia Canyon (SE of Parker Canyon Lake). (11 persons, 126 hrs)
- 6/19/85 Exhausted hiker and horse in Bird Canyon due to heat and lack of water. Extra horse and water taken in. (12 persons, 58 hrs)
- 6/22/85 Missing 16-yr-old on ATC vehicle in Agua Caliente Wash area. (36 persons, 160 hrs)
