On February 10, 1996 Civil Air Patrol units from all over Southern Arizona took part in a day long training exercise. The exercise was developed to test both the air component and the ground component of the C.A.P. units taking part. Realistic looking targets had been placed in the fields north of Marana. Aircrews were sent out first to scout the area and use electronic equipment to try and locate the "aircrafts" ELT. Ground teams were sent north shortly afterwards. After 3 hours of coordinated work between the aircrews, ground teams, and mission base personnel, one of the targets was located and a ground team was sent in to secure the site. As to the other target; well, even those that placed it had a hard time locating it. The Tucson Composite Squadron supplied all the ground teams, as well as the Ground Operation Director and two Communications Directors. All in all, it was a good training day with 8 aircraft and 4 ground teams taking part.

MEDICAL AND FIELD SKILLS QUALIFICATIONS

Each SARA member is responsible that a current copy of their
medical certification/or license and a copy of their current Field Skills
Checkout card is in the SARA field qualification records. Currently
Andy Lamb is updating the records and asking everyone to check that
current copies are in the field qualification records which will be at the
next several SARA meetings. April 1, 1996 has been established as
the "Drop Dead" date. After this date, if the records do not show a
current field qualification, the SARA person will not be allowed to
respond to callouts. Remember, only field-qualified members vote!

FIELD SKILLS QUALIFICATIONS

The SARA board passed a policy in 1993 that requires all
members to recertify their field skills every three years to stay field
qualified. All field qualified members as of October 31, 1993
received a field skills qualification which expires on October 31,
1996. Many members have attended a field skills recertification since
October 31, 1993 and have obtained a new field skills qualification.
All other members are require to attend a field skills recertification
before October 31, 1996 to stay field qualified.

The members who have not attended a field skills recertification
have three opportunities left 1996 to attend. The recertification dates
are April 27, July 27, and October 26. Please plan on attending a
recertification on one of these dates.

Note: Trainees receive a field qualification which is good for one year.

CALLOUT REVIEWS

Summary of Data

Reporting Period: 27 Jan 96 - 24 Feb Callouts: 11
SARCI People: 138 Total Hours: 566 Hrs/Person: 3.1

MON 5 FEB: CALL 96.010 Search for a ?? year old male off the Sonota Highway near the pass before the turnoff to Rosemont Junction. The subject was reported to be suicidal and his car had been found along the Sonota Highway. A search by helicopter during the night had failed to turn up anything, and we were called out first thing in the morning. Before too many people made it past rendezvous the subject turned up in Sierra Vista.
Rendezvous only.

SUN 11 FEB: CALL 96.011 Search for a 23 year old male in Pima Canyon. Initial report was that the subject was overdue from a short hike in Pima Canyon. Little was known about when the victim had left for his hike and his intended route. Several teams started out searching for the subject with one team spending the night at the spring, high in Pima Canyon.
14 people, 83 hours

MON 12 FEB: CALL 96.012 Continuation of the search for the 23 year old male in Pima Canyon. Several teams searched different areas in Pima Canyon with teams checking Table Mountain, Rosewood Peak, and several other areas. Helicopters search cliff areas and made several sweeps. Several teams of family members and friends also searched.
15 people, 117 hours, R38

TUE 13 FEB: CALL 96.013 Continuation of the search for the 23 year old male in Pima Canyon. Again teams searched areas in Pima Canyon with several teams of family members and friends. Helicopters made several sweeps checking cliff areas.
14 people, 71 hours, 305th ARS R38

TUE 13 FEB: CALL 96.014 Rescue of a ?? year old male hiker in Ventana Canyon. The victim was with a group of people who started hurrying out of the Canyon when it started to rain. The victim apparently slipped and injured his leg. He was only a short distance up the road from the trailhead in Ventana Canyon. RMFD was the first to respond and after trying to carry the victim a short distance they decided to call for more manpower with a stokes basket. We arrived shortly and helped bring the victim the rest of the way out.
11 people, 11 hours, RMFD

WED 14 FEB: CALL 96.015 Continuation of the search for the 23 year old male in Pima Canyon. The few SAR volunteers remained in basecamp, keeping track of a number of teams of family members and friends. Ranger 38 flew several sweeps of the area. The body of the subject was located at the base of a cliff, a short distance from the trailhead, by a solo person around 11:30. An hour later, other people wandered by with a cell phone, and called 911.
6 people, 23 hours, R38

WED 14 FEB: CALL 96.016 Recovery of 23 year old male in Pima Canyon. The recovery was efficiently conducted with Ranger 32 flying the body out of the field with a long line.
18 people, 43 hours, R32

SAT 17 FEB: CALL 96.017 Body recovery of a 24 year old male near Pine Creek Crossing in Sabino Canyon. A body was reported to be face down in a pool of water, 300 yards below Pine Creek Crossing. Initial teams were able to locate the body at the given location. A short haul system was setup and the body was pulled out of the water after being harnessed and connected to the haul system. Good team work was displayed with several people getting their chance on the stokes basket bringing the body out of the field. The victim had been in the water for several weeks.
21 people, 126 hours

SAT 17 FEB: CALL 96.018 Rescue of three people above the top of the switchbacks in Sabino Canyon. An initial team arriving for the body recovery in Sabino Canyon, found out that there were two adults and one child off trail above the top of the switchbacks. They did not have a flashlight but were using a camera strobe to signal. The team made their way to the victims and found that one of them had a sprained wrist. They had made the loop from the Visitors Center up the Seven Falls Trail to Sycamore Saddle and back down Sabino Canyon. They were fed, watered and the wrist taped up and assisted out of the field.
3 people, 7 hours

THU 22 FEB: CALL 96.019 Rescue of a 63 year old female with an ankle injury on the Pontatoc Ridge Trail. The victim slipped on the trail and twisted her ankle. She was located on the switchbacks below the junction on the trail. She was placed on the stokes basket and wheeled out of the field.
9 people, 17 hours, RMFD

SAT 24 FEB: CALL 96.020 Rescue of a 14 year old female with a leg injury at the base of Seven Falls in Bear Canyon. The victim has hit by a 40 lb boulder which was dislodged by a person climbing above her. She sustained abrasions to her thigh and lower leg. She may also have sustained a fracture to her lower leg. The victim was given a ride out of the field on the stokes basket with some gear being carried out by the Forest Service Mounted Assist Unit.
17 people, 58 hours, RMFD, C510

Feliz Navidad y Ano Nuevo, SARA,

Hola from Mark and Liz in Oaxaca. We are back in the big city of Oaxaca after being beamed down into the jungle, where we have resorted to eating iguana tamales (the lucky one gets the head) and generally living village life -- since the Starship Enterprise seems to have abandoned us. We did find that little village we were looking for, and now we're living there with a really wonderful family that has 9 kids. San Pedro Amuzgo is near the Guerrero border and about 4 hours straight up into the jungle from Acapulco. Unlike Acapulco, Amuzgo has no hotels, no beaches and one phone for the whole pueblo. They don't speak English and they don't take American Express. In fact a lot of people don't speak spanish -- they speak Amuzgo, an Indian language that sounds like soft falling rain and is hard as hell to learn, although we can say some useful phrases like "chicken", "cat" and "the tamales are tasty."

I have been busy learning how to accomplish manly tasks in the jungle. I march off to the rice and avocado fields with other men my age. They wear straw hats and carry large, rather threatening machetes that hang off their shoulders in leather sheaths. How savage. There are snakes (viboras) and wasps (avispas) hanging in the trees. Each

step is incredibly dangerous.

Elizabeth has been hanging out with the local curandera (herbal curer), as is appropriate for an anthropologist. She is learning the art of diagnosing where worms live in the body by tapping and massage -- something that can only be done between 5 and 6 a.m. when it is still dark. This skill is more useful than one would wish in this village where worms are in everything and everyone. Her womanly skills are increasing every day -- she can whip out tamales on banana leaves with the best of the street vendors. The incredibly beautiful backstrap weaving intimidates her almost as much as the Amuzgo verbs do however... The next big step will be learning how to pound our clothes on the rocks down at the river where one washes clothes (among other things...)

I have given up the idea of staging an episode of "Emergency 911" in Amuzgo and have resorted to building latrines. Only about half the households have this beautiful and marvelous technological invention of which our heartfelt appreciation grows daily. The local health promoters are into building latrines, and I will be digging the holes along with them. The cholera cots are stacked high at the local clinic after last year's quite fatal epidemic. Indiana Jones eat your heart out... ("Indy, Indy, what do we do next?" "I don't know, Miriam, I'm making this up as we go along...")

As aliens in this village we have been trying to learn local customs, like dancing and how to partake of fiestas and bodas (weddings). We are constantly under the proverbial microscope. After our first attempt at dancing we were critiqued by the local villagers on our dancing savvy -- "Why is it that you only move the top half of your body when you dance," they asked. It could have been the Doc Martins, or the fact that we are so TALL that they can see the top half of our bodies over the entire crowd. They also offered to throw us a wedding, if we would just get married...

We spent Christmas in Oaxaca city where we've had an apartment for the last three months and where we are when we aren't in the village. Marianne (Elizabeth's sister) came to visit us for the second time in the last three months (so everyone better go to your travel agencies and check out those plane tickets 'cuz this is a spectacular place!) She is also our mail courier and will be mailing these letters from Portland, Ore... We aren't just hiding out in a coffee shop up there.

We are now gearing up for 2 months in the village, then a month of doing research up in Sonora (where we will have a house on the Beach on Kino Bay between Feb. 23 and March 23... best put in your requests now!). Then we will be back down in Oaxaca for another 6 months or so.

We wish everyone a very very happy y prospero ano nuevo.

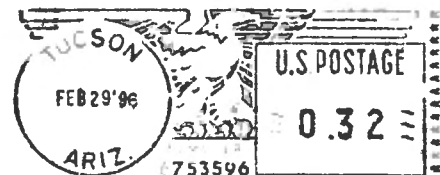
