We need to be sensitive to the reasons why our subject is missing. Usually our goal is to reunite the missing with their family. In this case, that was not appropriate, to the surprise of those directly involved with concluding the search.

When you are on a team that gets the feeling that you are dealing with a situation other than the typical late, lost, disoriented, or injured subject, then find a way to discreetly express your concerns.

Thanks to Tom Harlan for teaching the Map and Compass/ GPS training in May. The training emphasized what a useful tool the GPS can be.

The next training is Basic Rock Techniques. The presenter will be Jim Gilbreath. Rendezvous will be at 106 at 8:00 AM on Saturday June 7.

The training will take place at Windy Point where the parking is limited so we will be carpooling from 106. Plan on spending all day at the practice so bring a lunch. In addition to your lunch, bring a seat harness or 25 feet of 1" tubular webbing, about 12 ft of 7mm rope if you have it, and wear boots that you would normally wear on a callout. As always bring your SARA pack in the event of a callout.

CANDIDATE PROGRAM

The next opportunity to join SARA is August 12th. The candidate program begins with an introduction to Search and Rescue on Tuesday, August 12th, in the Tumbleweed Room at TMC. Candidates are taken on a hike to introduce them to what is required to get equipment to the scene where help is needed. The hike is scheduled for Saturday, August 16th. After the introduction and the hike, if they are still interested in joining SARA those who do not meet the minimum medical qualification may enroll in the Outdoor Emergency Care course schedule to start Tuesday, August 19th. Those who already have the medical qualification are required to attend the Saturday classes of the OEC class to introduce them to treating someone in the field.

Basic I & II will be held Saturday, October 11th & 25th. All candidates are required to attend Basic I & II.

NOTICE TO OEC TECHNICIANS

Mark Your Calendar

The Outdoor Emergency Care refresher is a three-year recertification program for OEC technicians. The Outdoor Emergency Care certification is good for three years. Satisfactory completion of three consecutive OEC refreshers along with payment of the OEC fee will generate OEC recertification cards for a three year period. OEC technicians must complete the OEC refresher each year. Any OEC technician who completed a full OEC course after May 31 of the refresher year is exempt from taking that year's refresher.

If you are unclear if your refreshers are current contact Andy Lamb because many of SARA's OEC technicians have missed previous refreshers and will need to take the full OEC course again.

SARA OEC Technicians have a minimum of four opportunities to complete the '97-'98 refresher. Plan to attend one.

WED 30 APR CALL 97.021 Search for a 69 year old male overdue on a hike to Romero Pools. Ranger 38 spotted the subject a quarter mile off trail, east of the first set of switchbacks on the Romero Trail. Ranger lit up the area for the first team as they traversed to the subject. The subject lost the Romero Trail as he was hiking back from Romero Pools and ended up at the bottom of Montrose Canyon. He had worked half way up the canyon to the trail but ran out of light and decided to wait for morning to come out. We provided food, water, and lights and assisted him back to the trail. Jasper, the rescue mule, provided a ride to the trailhead. 7 people, 23 hours, R38

MON 12 MAY CALL 97.022 Assist Graham County with a search for a 65 year old male diabetic in the Deer Creek area of the Galiuro Mountains. Graham County had searched during the day assisted by Ranger 41 out of Phoenix. We arrived about 9:00 pm and two foot teams of three and a Posse member started up the trail into the Mud Springs area were an individual matching our subject's description was seen Sunday afternoon. We searched most of the night getting a little sleep on the trail. At daybreak we searched around the Mud Springs area finding no sign. Our teams then headed back to base camp as other teams were being deployed into the field. As teams were being ferried into the field by helicopter the subject was spotted not far from the Mud Springs area. Ranger 41 brought the subject back to basecamp. It was a good operation with several counties participating.

8 people, 151 hours, R41: Graham, Cochise, & Greenlee Co.

MON 26 MAY CALL 97.023 Rescue of a 20 year old male with a snake bite, well upstream from the Upper Falls area of Tanque Verde Falls. The call was reported by cellular phone and it took a while to locate the victim, with help from Ranger 32. Ranger was able to land near by, loaded the victim, and flew him to TMC. Bystanders reported that the victim had been playing with the snake, and was bit on the lower leg, resulting in a lot of pain and swelling. 11 people, 20 hours, R32

TUE 27 MAY CALL 97.024 Search for a 12 year old girl missing from a residence in Avra Valley. Canine and support people were requested late in the evening. 8 people, 64 hours, R32

WED 28 MAY CALL 97.025 Continuation of search for 12 year old girl. She and a younger brother ran away from home, attempting to escape an undesirable home environment. The two were separated almost immediately, with the brother being found and returned home shortly after. She apparently wandered in the desert area near her home at the west end of Tucson Mtn Park, not responding to search teams or to Ranger overhead. As teams were starting into the field in the morning, heading to the end of the trail of footprints, she was observed hiding in bushes near a residence not far from her home. Searchers found her nearby, scratched, dirty, thirsty and hungry, and not wanting to be returned home. That case continues, but she and her siblings are now away from their home.


