#### TECHNICAL RESCUE EXERCISE

The Technical Rescue Exercise will be a mock search and rescue mission at Rappel Rock. Rendezvous is at 106 at 8:00 AM on August 16. This exercise is open to all members of SARA. It is an ideal opportunity to participate in a high angle rescue. We need a good turn out to fully accomplish all the elements of this search and rescue mission. There is an important position to be filled by members and candidates of all skill levels. Anyone wishing to go over the side needs to be self sufficient in terms of ascending and descending fixed lines. This practice is not intended to teach these skills.

The following personal equipment will be required for anyone working over the edge: helmet, seat harness, (2) multi-loop/prucells straps, (5) locking carabiners, a personal belay/ rappel device, and a set of ascenders with leg loops. In addition, these personnel should have a small pack to carry food, water, rain gear, warmies, and a head lamp. This training will be a difficult challenge for all involved, don't miss it.

Scenario: Report of three overdue climbers thought to be on Rappel Rock. Unknown experience and equipment. The trio has been missing since Friday morning and the S.O. was able to confirm that the vehicle is at the trailhead.

Basic I & II will be held Saturday, October 11th & 25th. All candidates are required to attend Basic I & II.

# NOTICE TO OEC TECHNICIANS

#### Mark Your Calendar

The Outdoor Emergency Care refresher is a three-year recertification program for OEC technicians. The Outdoor Emergency Care certification is good for three years. Satisfactory completion of three consecutive OEC refreshers along with payment of the OEC fee will generate OEC recertification cards for a three year period. OEC technicians must complete the OEC refresher each year. Any OEC technician who completed a full OEC course after May 31 of the refresher year is exempt from taking that year's refresher.

If you are unclear if your refreshers are current contact Andy Lamb because many of SARA's OEC technicians have missed previous refreshers and will need to take the full OEC course again.

SARA OEC Technicians have a minimum of four opportunities to complete the '97-'98 refresher. Plan to attend one.

Last month a brief overview of the thoughts of the board appeared in this space. Richard Kunz has asked me to chair the building committee. I have accepted and will attempt on a monthly basis to keep you informed as to progress. I hope to also ask for your help. As with any project, be it a search or rescue or a longer term undertaking such as this, it will only happen with the help and input from the membership. So that you may easily provide input, from time to time at the end of each report will be a list of the committee members and their phone or e-mail addresses.

The board has officially dedicated a Building Fund into which contributions can be made. The initial funds (\$2,000) came from a donation by the Southern Arizona Hiking Club in memory of Eber Glendenning. The fund raising chairman is Mark Romero, current SARA Treasurer.

A group met with Jim Gilbreath early in July to participate in a space planning exercise. This will result in a rough design for a structure. Jim will have this available at the August meeting. It will represent the wish list of desires. It is a place to start for discussion. It does not necessarily represent the building to be built, but serves as a strategic planning document to be altered to meet SARA's needs and financial capabilities. It might for example represent a long term plan which might be built in several phases, depending upon cost. I hope that you will take advantage of reviewing it at the meeting and provide feedback to members of the board or committee.

At the outset I said I would be asking for your help in this endeavor. Many of us have skills and talents which could be useful to SARA on this project. It would be helpful to have an inventory of skills and experience to call upon during the process. By revealing your talents you need not be concerned that you will be roped into providing them. At this time it would be useful to know who has what experience so that as planning progresses we might ask your advice, either directly on a specific question or to help the committee identify or qualify non-SARA resources. Experience in any aspect of the project would be appreciated. Examples include fund raising, legal (document review and preparation), insurance (liability, construction), design and engineering of plans, overall construction management, site preparation (grading, utility placement), cement work and foundations, framing or ???, electrical, plumbing, phone, sheet rock, cabinetry, furniture, appliances, carpeting, roofing, landscaping, paving, to name a few. Please contact any of us and let us know your talents and experience so that we might ask for your assistance and guidance as the project progresses.

MON 07 JULY CALL 97.??? Search for three overdue hikers on the Box Camp Trail, Santa Catalina Mountians. The three started hiking down the Box Camp Trail from the top with the intention of coming out at the Sabino Canyon Visitors Center Monday evening. Initial teams started up from the bottom with a posse team coming in from the Prison Camp. No contact was made by the time teams had made it to Pine Creek Crossing. So one team started up the Box Camp Trail with another team going over to Hutch's Pool. ?? people, ?? hours

**TUE 08 JULY** CALL 97.??? Continuation of the search for the three overdue hikers on the Box Camp Trail. Teams continued with the search, with the team continuing up the Box Trail, and a team of one starting at the top of Sabino and coming down to Hutch's Pool. Others search in the Pine Creek Crossing and Hutchs' Pool areas. ?? people, ?? hours, R41

**TUE 08 JULY** CALL 97.??? Rescue of a ?? year old male climber near Windy Point in the Santa Catalina Mountains. He climbed too far above his last protection and fell to the ground, sustaining facial lacerations and a head injury. He was short hauled by Ranger 41 to Geology Vista. ?? people, ?? hours, R41, Mt Lemmon Fire, RMFD

WED 09 JULY CALL 97.??? Continuation of the search for the three overdue hikers on the Box Camp Trail. The search continued with the Posse holding at Pine Creek Crossing, and with several helicopters involved. After several periods of hollering and listening, voice contact was the made with the subjects near Pine Creek Crossing. Ranger 38 was able to land near by and pick up the victims. The victims said that they were hiking down the Box Camp Trail on Monday afternoon when a thunderstorm passed by and forced them off the ridge. They could not find the trail again and ended up coming down the side canyons. ?? people, ?? hours, R38


**TUE 15 JULY** CALL 97.??? Body recovery 3.5 miles up the Redington Road. The body was located approximately 150 feet off the side of the road. A haul system was set up to help bring the body up to the road. ?? people, ?? hours

**SUN 27 JULY** CALL 97.??? Missing 10 and 12 year old boys from a picnic in Rose Canyon. Lots of candidates, but few searchers familiar with the area. Few details were available to indicate that the boys were more likely to be in one area. A team of one headed down Rose and Sycamore without any sign. A team hollered from Rose Peak for a long time without any response. Later teams worked on Willow Canyon. Reports of sightings in the Willow Canyon homes area were checked by dog and foot teams. The persistent Rose Peak team began hearing the boys in Sycamore Canyon, below Rose Canyon. A second team headed into Sycamore while Ranger 38 would search for awhile, then go away while voice contact was re-established from Rose Peak. A bottom team climbed up the opposite side of the canyon, hoping to be able to hear the boys on the slope under the peak, but they still could not be heard from below. A prominent side drainage starts between the Girl Scout and Presbyterian Camps, and has funneled missing kids down into Sycamore, and that drainage was beginning to sound interesting. Note that people can estimate the direction to people hollering, but it is difficult to estimate how far up or down they are. The team reached a point where they were beginning to look into the side drainage, so the helicopter hopped over the ridge, the Rose Peak team hollered, and finally the response was heard by another team. Ranger 38 was recalled and pointed up the side drainage about a quarter mile, and the boys were quickly spotted. The helicopter attempted to put the medic on a bare section of rock, but the boys kept running for the same place. The ground team met the boys as Ranger returned. The boys were in good shape. They were going to head downstream in the morning. After all, they could SEE Tucson! ?? people, ?? hours, R38

**SUN 27 JULY** CALL 97.??? Missing 9 year old boy, near Sandario and Mile Wide in Avra Valley. The search started while the Rose Canyon search was starting. He was located before people got to rendezvous, but not before people did a lot of driving across town, especially posse people switching between bring-a-horse and be-a-hiker modes. ?? people, ?? hours

**TUE 29 JULY** CALL 97.??? Body recovery of 4? year old male apparent suicide, Blackett's Ridge, Sabino Canyon, Santa Catalina Mountains. A hiker missing from the previous day was suspected of being suicidal. TJ and SAR Reserve Scott Lonergan hiked up the Phoneline and Blackett's Ridge Trails. A fanny pack was found, matching the description of the hiker's. Scott spied something suspicious, well below the base of the cliffs, and Ranger 38 confirmed the find. Four people were flown to a saddle a quarter mile from the scene and equipment was short-hauled. The cliff is about 200' high, and the first evidence of disturbed ground was about 100' from the base, and the body was another 200' down the steep slope. A rope was set up for those working at the scene, and a 3-to-1 haul was used to move the litter up the slope and clear of a tree at the scene. ?? people, ?? hours, R38
