SEARCH AND RESCUE COUNCIL

Cellular Telephones have been installed in each rescue truck.

Rescue 330 237-1769 (SARA-1) Rescue 331 237-1997 (SARA-2) Rescue 332 237-2940 (Rescue-3)

Each of these phones are set up to answer automatically, if they are not picked up by the third ring (IF the phone has been turned on and unlocked!). The speaker is in the base of the handset, and the remote microphone is up near the driver's sunvisor. So you may hear someone holler at you from the back of the truck, or you may hear radio traffic, or both! The mike is voice-activated (VOX), so you may hear background noise only while hearing a loud sound (nearby voices or radios).

Please remember that activities at the start of a call can be hectic, and incoming telephone calls should have low priority. We can't tell you how many people are coming, or whether we need more people. Your best source of info is by listening to the radio, and your experience.

After an hour or so, answering the phone is less distracting. We should have enough info by this time to update AUDIX with the call status, and any needs for more people.

Mine Rescue Training

Mine Rescue Training will be held on Saturday, 27 September. Rendezvous will be on the northeast corner of Orange Grove and Thornydale. This will be a continuation of last year's training. It will be run as a body recovery with "the body" being various items the owners wish to have retrieved from the mine. We will dispense with the search portion of the training and begin by rigging for a vertical operation and begin the retrieval.

Last year, entry into the vertical shaft was limited to a small number of participants by the cover over the collar and low oxygen readings in the shaft. We will remedy the first problem by removing the cover, and hope to remedy the second by employing a device to provide air flow in the shaft. Oxygen concentration will be monitored by a member of each team entering the shaft. I hope that we can deploy teams on a rotating basis so everyone that wants to will have an opportunity to participate.

The mine consists of a vertical shaft with a couple of horizontal drifts at various levels. A series of ladders provides access, although individuals will be on belay during ascent or decent. We will rig a tripod or other device to facilitate hauling objects up the shaft.

I am looking for volunteers to assume the duties of operations leader, safety officer, rigging team leader, etc. I hope that we will have a large enough turn-out that those that volunteer (or get volunteered) for the leader positions will be able to rotate into underground teams should they desire.

Rendezvous will be at 7:30. Be gassed up and ready to depart shortly thereafter (7:40). The drive is about an hour north and west of rendezvous. If you're late, read the cone and come on out anyway. We'll be at this probably until early afternoon.

Now the incentives beyond hanging out (perhaps literally) with your fellow SARA members. Cindy Coping has offered her ranch to anyone caring to go out on Friday night and

camp out. Besides horseshoes, volleyball, petroglyphs and stargazing as potential entertainment, you won't have to get up early on Saturday to make rendezvous. Bring your own food and camping gear. For those participating in the training on Saturday, Cindy will provide a cookout immediately following, supplying your choice of steak, chicken or vegetarian fare and appropriate accompaniments. THERE IS A CATCH HOWEVER. YOU MUST TAKE THE RESPONSIBILITY TO R.S.V.P. WITH CHOICE OF STEAK, CHICKEN OR VEGETARIAN TO CINDY'S MESSAGE MACHINE AT 575-1563 PRIOR TO WEDNESDAY, 24 SEPTEMBER AND THEN FOLLOW THOUGH AND SHOW UP! Grand Canyon Clean-Up

DATE: Oct. 11 (Saturday), 0800 Hrs. PLACE: South Rim, GCNP

We will be participating in a trash clean-up with AMC & CAMRA. This clean-up will involve 200 foot rappels (usually less) with ascending required to get back up the rope. Vertically qualified personnel will be doing SRT (single rope technique, with no belay). Support personnel are welcome and can be used to help at the top.

We will all be camping out in the group site area (Mather campground, Sage Loop) which will be staked out early by AMC. Since there is only room for a few vehicles at the actual campsite, we will be dropping off our gear and parking nearby at Babbit's Store. There will be a pot luck/ barbeque on Saturday night at Shoshone Point, a remote picnic area on the way to Cameron.

SARA's plan is to go up Friday night and meet AMC at the Canyon, work Saturday, then return Sunday or whenever people want to.

Those who wish to go over the edge must be vertically qualified and must be able to demonstrate their abilities. Requirements are to be able to ascend and descend (with intermediate stops and tie-offs for trash collection) and be able to switch from ascenders to rappel device (and back again) on the rope (not standing on the ground - there may not be any!). There are usually some smaller drops which may be worked by those who are not as skilled at ascending, but you still need to qualify.

A practice session will be held prior to the event at the PCSO's training site on Rita Road just south of I-10. A distinguished (notorious?) panel of judges will be there to assess your skills and answer questions. If we are aware of your vertical qualifications from past trips, your attendance may not be required, but please ask first. I have personally given my word to AMC that we will not drop anyone!

If you are interested in going, please call me and I will put you on the list. I will let the participants know when the training session will be as well as all other details as the time draws near.

NOTICE TO OEC TECHNICIANS

Mark Your Calendar

The Outdoor Emergency Care refresher is a three-year recertification program for OEC technicians. The Outdoor Emergency Care certification is good for three years. Satisfactory completion of three consecutive OEC refreshers along with payment of the OEC fee will generate OEC recertification cards for a three year period. OEC technicians must complete the OEC refresher each year. Any OEC technician who completed a full OEC course after May 31 of the refresher year is exempt from taking that year's refresher.

If you are unclear if your refreshers are current contact Andy Lamb because many of SARA's OEC technicians have missed previous refreshers and will need to take the full OEC course again.

SARA OEC Technicians have three more opportunities to complete the '97-'98 refresher. Plan to attend one.

SARA BUILDING COMMITTEE UPDATE

The Building Committee has been divided into three subgroups. These are: New Building Design and Construction, Temporary Building Acquisition, and Fund Raising. This was done so that those interested in any of the subcommittees would not have to attend meetings where all were discussed.

Only the Fund Raising Group has met since my last update. Mark Romero, SARA treasurer is the chair. He has a report elsewhere in this month's Newsletter. An account to manage funds is being set up. The next meeting of this group is set for October 8 at 6:30 pm at a place to be determined. Contact Mark for details. We have met with an experienced individual who will guide our thinking about how to structure a fund raising campaign. We will be discussing the planning of this campaign at the 8 October meeting. It is important that we do this properly since we may only have a single opportunity with a donor, so we want to make it an effective contact. Before contacting any donor, please check first with Mark so that he can coordinate and provide you with material. A brochure is in the works, and will also be discussed at the October 8 Fund Raising meeting.

The Temporary Building Acquisition is being headed by Richard Kunz, who is working with Pima County representatives on a specific property. No decisions have yet been brought to the SARA Board regarding whether this is a viable opportunity.

The New Building Design and Construction Group, headed by me, is awaiting completion of work on a preliminary design. The preliminary plans will be available at an upcoming SARA monthly meeting. Upon their completion, the SARA Board can debate and make decisions on what is to be included in the new building. Once that decision is made we will know what our target for fund raising is. Estimated cost of the building is \$54 per square foot. Designs range from 4000 to 7000 square feet. The September monthly meeting will be held in a recently constructed building having features which may be considered for ours. Please attend to get an idea what this structure looks like. Richard Kunz continues to work with Pima County representatives and others to identify available properties which meet our geographic parameters of a central location for the building.

A Catalina State Park Ranger headed up trail and located the victim about 3/4 of a mile off trail. The ranger was able to get the victim back to the trail where Jasper the Rescue mule carried him out of the field. 8 people, 20 hours, R38 and Catalina SP Rangers
