Training Review The Vertical Mile Hike

The 1999 Vertical Mile Hike up the Palisades Trail on November 20 attracted a record number of outdoor enthusiasts, from toddlers to "seniors." (and those who just felt like seniors by mid afternoon). Sixteen SARA members, and their friends and families tackled the almost 15 miles of trail from Sabino Visitors' Center in the saguaros up about 5000 feet of elevation gain to the Girl Scout Camp in the pines.

Starting before dawn, seven hikers formally "competed" in this non-competitive event by walking the distance with a pack weighing at least 20% of their body weight. David and Sherry Mulkey added interest to the day by packing up their 2 children, Aaron, age 2, weight 35+ pounds, and Jesus, age 1, weight 25+ pounds. Their formula seemed to work; they came up in the shortest time --- 6 hours flat --- all four looking like they did this daily and loved every minute of it.

They were followed, more than an hour later by Jurgen, then Brad, Jackie, Henry and Karmin. The "Vertical Mile Lite" entrants carried packs like John Perchorowiczs' that weighed 10 pounds sopping wet, and some even waited to catch the first tram and so sat out the first 3.7 miles. However, all made it up in good time: first John in 6 hours, 5 minutes, then Josh, Sue, Sally, Robert, Marvin, and Andy.

Many thanks to Gary Copus who provided radio communications with the flock throughout the hike from the road above the Mt. Bigelow turnoff. Thanks also to Richard and Fran for help with trail flagging, picnic logistics and (with Gary) for transporting all those exhausted sweaty souls back down the hill. We would also like to thank The Summit Hut for donating items for the event.

The Vertical Mile involves speed, stamina, trail following and a chance to learn a bit more about one's own capabilities. At its best, it also involves teamwork and friendship and a good time (at least in retrospect). This year's group distinguished itself in all these areas, finishing strongly in very good times and with enough energy left over to look out for the rest of the team and cheer them as they came running and skipping (Jurgen!) into camp. Hats off to the whole pack!

THU 11 NOV CALL 99.098 A 65 year old male hiker collapsed about four miles up the Pima Canyon Trail, above the dam. The victim was in good condition, training with his son for a trek in New Zealand, and had no history of cardiac problems. The son got ahead of his dad and waited for him to catch up, then walked back when he didn't show up. He found his dad face down on the trail, and started CPR while calling 911 by cellphone. Ranger 38 dropped the medic off near the scene, and the patient was pronounced. The pilot was unfamiliar with our SAR people, the drop-off point required a hover egress, and the medic was on scene with the son. A SARA member hiked to the scene, then Ranger could fly the son and medic to base camp, and ferry stokes and a second volunteer to the scene. The victim was short-hauled to base camp, then the volunteers were picked up. Ground teams were out of the field shortly afterwards. 14 people, 61 hours, R38, RMFD

THU 11 NOV same call A ?? year old female tripped on trail and injured her knee and ankle a short distance from the Pima Canyon Trailhead while the body recovery was in progress. Rural Fire treated the patient, and asked for our assistance carrying the patient back to the trailhead.

MON 15 NOV CALL 99.099 Search for a 79 year old female Alzheimer patient walk-away from her residence in Continental Ranch, near Cortaro Farms and Silverbell. She was last seen Saturday evening. We were requested about 48 hours later. After we arrived at base camp a teenager rode up on his bicycle and said that he and his mother had possibly located the subject near the Santa Cruz River. The Marana Police and Deputy Rick confirmed that she was our subject. No SARCI members made it into the field. 14 people, 18 hours, R38

THU 18 NOV CALL 98.100 Search for a 3 year old male near the town of Sanchez east of Safford. Pima County Search and Rescue teams were requested by the State Office of Emergency Management to assist with the search. The subject had been in his backyard with the family dogs. His mother noticed him missing around sunset on Wednesday evening. The dogs returned but the little boy did not. Graham County started the search with assistance from other counties through out the night. We arrived about 08:30 with lots of horses, dogs, and foot teams. Shortly after we arrived a Phoenix news helicopter spotted the subject about a mile from the house. A Maricopa County Sheriff's helicopter brought him back to base camp. The little guy was OK despite spending a chilly night outside, without any clothes.
