Ham License Restructuring

Last months article left some people unclear about what the new license structure means for S&R people. The Technician license is still the minimum for using VHF and UHF ham frequencies, in addition to several other bands. A single 35-question test replaces two previous exams that were required to qualify for Technician. As before, you don't need to pass the code test unless you want privileges on HF frequencies (below 30MHz). Existing privileges will not automatically change, unless you upgrade.

Activity Records

Summaries of activities in addition to callouts are requested of many SARCI groups during their fundraising efforts. Many hours are contributed during public service activities with little documented evidence recognizing the contributions by numerous volunteers.

MON 03 JAN CALL 2000.001 7 people 14 hours SCSAR

Search for a 19 year old male and a 24 year old male overdue on a hike in Madera Canyon. The subjects walked out as search people were getting to the lodge. No one made it into the field.

TUE 04 JAN CALL 2000.002 9 people 87 hours SCSAR, Sonoita Fire, Tubac Fire

Cave Rescue of a 4? Year old male with a leg injury in the entrance pit of Oynx Cave in the Santa Rita Mountains. The patient was completing a caving trip and had gotten the rest of his party out of the entrance pit when he fell 5-10 feet and suffered a tib-fib fracture. Sonoita Fire were the first ones on scene followed by Tubac Fire, SARA, and Santa Cruz SAR. The patient was packaged into a Sked Stretcher and hauled to the cave entrance, then loaded into a Stokes basket. The patient was hauled up to the top of the ridge using a haul system then wheeled down the ridge to basecamp.

SAT 15 JAN CALL 2000.003 6 people 6 hours RMFD

Rescue of a ?? year old male patient with a leg injury on the trail between the Sabino Canyon Visitors Center and the Seven Falls Trailhead. The patient was located 300 yards before the trailhead. RMFD was loading him into the ambulance as the first teams were arriving. No one made it into the field.

SUN 16 JAN CALL 2000.004 21 people 38 hours MLFD Rescue of an injured hiker near Geology Vista on the Catalina Highway. The patient was located about 200 yards from the road. MLFD had the patient packaged when the first team was arriving. The first team helped MLFD with their Stokes and got the patient to the road on an easy trail-of-use.

SUN 16 JAN CALL 2000.--- 0 people 0 hours

Search for overdue hikers in Pima Canyon. A group of seven hikers hiked up to the dam, then headed up a gully towards Table Mountain, then turned down-canyon on the usual route. The group became separated and three did not make it out to the trailhead before nightfall. After we were paged TJ started hiking up-trail and ran into the three near the Forest Service boundary. No one else made it into the field.

SAT 22 JAN CALL 2000.005 18 people 64 hours

Stranded hikers below the Willow Canyon Overlook north of Geology Vista. The four hikers ended up in Willow Canyon after a midafternoon hike to Rose Canyon Lake. A passerby noticed the three signal fires that the victims had started. Teams hiked in from Rose Canyon while a single team hiked in from Col. Birdseye to direct teams to the victims. Everyone was OK and were hiked back to Rose Canyon Lake after the fires were extinguished.

Assist MLFD with a fall victim with a ankle injury near Windy Point. MLFD was able to get the patient out of the field before anyone made it to Windy Point. The victim noted that he did not hook himself up correctly for a rappel, and fell about 30' from near the top of Hitchcock Rock. The immediate problem was a punctured aorta. He also shattered his right arm and fractured his left ankle, pelvis, and ribs, in addition to internal injuries.

A mother and daughter hiked down the Phoneline Trail, but ran out of daylight before reaching the trailhead. They didn't have any lights, but called for help by cellphone. They described passing a junction before dark that indicated 0.8 miles to go, and they were at another junction that included the Phoneline and Bear Canyon Trails. While we headed for Sabino, we recommended that the responding deputy drive to Lower Sabino and stop after crossing the stream, then shout for the women about 50 yards in front of his vehicle. He did and that's where they were. The deputy walked the short distance up the trail, and nobody else got into the field.

THU 27 JAN CALL 2000.008 9 people 54 hours

A 34 year old male hiker got a late start hiking up Sabino Canyon. He intended to continue up the West Fork, up and over Cathedral, and down Esperero Canyon. He ran out of daylight a short distance above Bridal Veil Falls. His father reported him overdue. Ranger 38 spotted a fire and the coordinates appeared to be appropriate. A couple teams of two headed up trail from Bird Canyon, reaching the fire about 03:00, and the overdue hiker. He was in good condition, and all made it out about dawn.

FRI 28 JANCALL 2000.0094 people4 hours

Two girls were reported to be in the bottom of Bear Canyon, below the Seven Cataracts Vista, and unable to find their way back up. A couple of bystanders led them out as SAR people were meeting.
