Pagers

There are now a significant number of alphanumeric pagers amongst our members. All of these pagers should include both the SARCI group (just like the numeric pagers), and the ALERT group. Alpha pagers should include the SARCI or ALERT label on group calls. If yours does not include both groups and both labels, please visit the VeriZon (Airtouch) office.

The ALERT system is intended to provide the SAR officers with a simple way to request a volunteer response. They call the pager number and leave a message, then one of the designated members retrieves the message and does what is requested. Everyone with an alpha pager needs NOT to respond to any ALERT page, unless designated to do so! Use it as a "heads up" for callout pages shortly.

Callout information (in words) can be paged on the ALERT system after the usual numeric page, when someone has the means to do so (about 25% of callout pages so far). This is a versatile system, while everyone helps make it work!

Pool Sessions: Rich Kunz

The class and pool session is required at least every three years, if you plan to get in the water during the River Rescue Training. You are expected to swim 4 laps (2 laps with a PFD and 2 laps without), then tread water for 5 minutes without a PFD (Personal Flotation Device). For the pool session you will need a Type 3 or 5 PFD (the SARA truck has a few), towel, swim suit, and a change of clothes. Please don't forget the swimsuit. A class session will follow the pool session at the SARA House.

The River Rescue practice will consist of reading the river, use of throw bottles, crossing the river, and swimming the river (depending on the depth). You need a wet suit, helmet, a Type 3 or 5 PFD, and have completed a pool session in the past 3 years. Of course, water in the river will also be required. Wet suits can be rented from local dive shops. Practice is a full day, so bring a lunch.

SUN 28 MAY CALL 2000.043 0 people 0 hours USFS

Search for a party animal in Box Canyon. The subject walked away from a party during the night in the Box Canyon area in the Santa Rita Mountains. As we were arriving at rendezvous a forest service ranger spotted the subject riding in a vehicle.

MON 29 MAY CALL 2000.044 16 people 23 hours

Rescue of a 53 year old exhausted female reported near Romero Pools. Catalina State Park Rangers met the patient near the top of the switchbacks on the Romero Trail. The patient was given a ride out by the posse.

MON 29 MAY CALL 2000.045 10 people 10 hours MLFD

Rescue of a 19 year old male reported to have a heat related illness two miles down the Red Ridge Trail. The group hiked down from the top, and he became ill on the walk back up. Two of his companions hiked out for help. A MLFD medic and two PCSO deputies hiked in to the patient. Eventually a couple of foot teams made it to the patient. The patient rode out on horseback.

MON 29 MAY CALL 2000.046 17 people 45 hours

Rescue of a group of exhausted hikers reported to be 2 miles above the end of the road in Sabino Canyon. The group of four had hiked to Hutch's Pool in the middle of the day with very little water. One of the group was having heat related problems on the way in. They started back from the pools and she continued to have heat problems. The group was met on the switchbacks by the first teams.

WED 14 JUN CALL 2000.047 16 people 77 hours Ranger 38, USBP, US Customs

Search for a undocumented 43 year old exhausted female who was left in the desert east of Green Valley by her companion who walked out to get help. Several teams of volunteers and Border Patrol people searched for the subject over several miles of open land. Ranger 38 and a Custom's helicopter helped with the search. The subject made it out to the road and was spotted by RMFD Captain.

FRI 16 JUNCALL 2000.0484 people7 hoursRanger 38, RMFD

Rescue of female thrown from a horse into cactus and rocks, near Fenster School. Ranger landed nearby; we didn't get into the field.

FRI 16 JUN CALL 2000.049 14 people 64 hours Ranger 38

Search for a 23 year old male hiker who called on a cell phone to report that he had fell and was off trail near Pictograph Spring on the Davis Spring Trail. Teams started down the Knagge and Butterfly Trails and a team drove around to Davis Mesa. Ranger 38 also participated in the search. The subject walked out at the Palisades Ranger Station having bushwacked to the road.

MON 19 JUN CALL 2000.050 8 people 8 hours

Rescue of a 60 year old exhausted male hiker on Blackett's Ridge. The patient was with a group of hikers from Canyon Ranch. He cramped up on the steep part of the trail, but was doing much better on the more level sections. The party way met the first team a short distance from the trailhead.

SUN 25 JUN CALL 2000.051 16 people 59 hours Ranger 38

Rescue of a 42 year old exhausted male hiker with a group of three others five miles up Bear Canyon. The group made a cell phone call for help and also provided GPS coordinates. Ranger 38 spotted the group continuing down trail, below the upper switchbacks 1.5 miles above 7 Falls. The first team met the group on the switchbacks above Seven Falls. After feeding and watering the group was able to continue. The patient was given a horse ride from near the sixth stream crossing.

TUE 27 JUNCALL 2000.0520 people0 hoursRanger 38, Mescal Fire, Benson and Cochise people.

Recovery of a 16 year old female who fell at Paige Creek Falls in Happy Valley. We were requested to assist a technical evacuation, but Ranger 38 found a place to park that was easier to get to. Rendezvous only.
