Pagers

Service for Verizon pagers has become difficult since their Tucson offices closed and our accounts transferred to Phoenix. We may be required to purchase our pagers, otherwise turn them in and discontinue receiving pages. So, we will not be issuing any more paperwork authorizing members to start service with Verizon.

SARCI pagers are now using Arch Paging. We are working with them to set up service suitable for SAR people. The cost for alpha pagers will be less than \$8.00 per month, including insurance (but there is a deductible). A voice mailbox is available for another \$1.00/month. SARCI Authorization paperwork will be required to obtain this price, and to add the SAR group numbers. Arch also requires a credit application. Depending upon your credit, there may be initial costs that include part of the pager cost, a deposit, and/or prepaid service. Billing is quarterly. We expect to be able to support new individual pager accounts at some time during April.

THU 01 FEB CALL 2001.008 15 people 117 hours USFS

A 2 year old male was missing from a residence at Quijotoa, between Sells and Ajo. Several agencies searched thru the night.

FRI 02 FEB CALL 2001.009 16 people 68 hours Customs, Ranger38, TohonoO'odham, Border Patrol Continuing search for 2 year old male. Teams following skimpy track continued after dawn, and found the boy in good condition about a mile west of the residence.

MON 05 FEB CALL 2001.010 6 people 78 hours FBI

Cadaver search by the Canine Team, south of Lukeville in Mexico.

TUE 06 FEB CALL 2001.011 9 people 10 hours Ranger 38

A 50 year old female hiker injured her ankle, near the Stone Cabin along the Yetman Trail in Tucson Mtn Park. Ranger 38 landed nearby and helped the hiker to the helicopter.

WED 07 FEB CALL 2001.012 12 people 22 hours Ranger38

The Sheriff's Department was working with evidence of a possible homicide in a desert area near Irvington and San Joaquin. Several teams covered the area without finding anything interesting. The reported victim was located uninjured by investigative means.

SUN 11 FEB CALL 2001.013 19 people 32 hours

A 53 year old female hiker injured her knee near the fifth crossing in Bear Canyon. Two SAR members arrived while on a recreational hike and requested assistance. She rode out by horse.

TUE 20 FEB CALL 2001.014 12 people 36 hours Ranger 38, SAV

A 70 year old male with Alzheimer's was missing in Green Valley. SAR teams covered desert areas while SAV covered the residential area. He was found by a SAR team in good condition soon after teams got into the field.

SUN 25 FEB CALL 2001.015 21 people 88 hours Ranger38

A 41 year old male hiker was overdue from the Sycamore Reservoir area. Teams covered trails leading to Sycamore Basin, and the hiker was found in good condition not far from the trail in the Basin. He had camped for the night after becoming disorientated.

THU 22 MAR CALL 2001.016 20 people 27 hours RM73

A female fell along Sabino Creek, bruising several parts of her body. She was helped down to Anderson Dam, then was unable to continue. Rural Fire medics had her ready for transport by the time the stokes arrived, and the carry out was done a few minutes later.

SAT 24 MAR CALL 2001.017 15 people 41 hours

A 31 year old male hiker twisted his knee a short distance upstream from the sixth crossing in Bear Canyon. His leg was splinted and the horse ride was uneventful.

SUN 25 MAR CALL 2001.018 19 people 80 hours Ranger 32, RMFD


A male hiker twisted his ankle a short distance above the first dam along the Pima Canyon Trail. Ranger 32 dropped off their medic a short distance away, and the hasty team arrived a short time later. Equipment was short-hauled to the scene, and the patient short-hauled to basecamp.
