


NEW SARA POLICIES APPROVED

All of the SARA policies have been organized into a single document and have been approved by the SARA Board. The Policies document is available on the SARAdocs web page and a printed copy is posted next to the Board minutes at the SARA house. There are also a few spare printed copies in the SARA Board room on the table.

The membership policy and the support membership policies have also been updated and incorporated into the new Policies document. Per the existing membership policy, any change to the membership policy requires that the changes be published in this newsletter, that the changes be discussed at a following general meeting, and only if no substantial changes are required following the general meeting that the Board can then approve the changes after two months have passed since the changes were submitted to the Board.

Most of the changes were organizational and grammatical in nature to allow incorporation of the membership policies into a single Policies document. As a result, the volume of changes was deemed too great - and thus too expensive - to publish the changes in this newsletter. Hence, the full text of the changes is published both on the SARAdocs web page and in printed form at the SARA house. The SARA Board will be present at the August general meeting to discuss the changes in the membership policy. Romero Canyon Trail, Catalinas

13:13 – 13:20 A hiker was reported exhausted about a mile up the Romero Trail. If this was a mile from the public trailhead, the call wasn't going to last long since park vehicles can drive that far. We were quickly cancelled.

8.044 Sun, 22 Jun 3 3 19yf missing

Picture Rocks, Avra Valley

19:38 – 20:38 A group of kids were at a party in the area, and a few went for a drive in a desert area in the early morning. After an argument, a 19yf left the vehicle on foot (barefoot). Her companions left a bottle of water and a note, and reported her missing later in the morning. She had not turned up by late afternoon, so a search started at the PLS. A Customs helicopter covered the square mile of desert without finding anything. A couple of deputies started following barefoot prints through a nearby rural area as SAR people arrived to assist. Investigative leads discovered that she had been admitted to a hospital with injuries, and was released in the afternoon, so the search was discontinued.

8.045 Sun, 29 Jun 13 26 3 mtn bikers lost

Crystal Springs Trail, Catalinas

17:25 – 20:41 Three mountain bikers started from Radio Ridge, intending to ride to their other vehicle in Bear Canyon via trails and roads. After passing Crystal Spring, they lost the trail, finally deciding to head uphill towards the highway. They had been in contact with family members, who called for help. As a team started on the Butterfly Trail from Soldier's Camp, the exhausted bikers/hikers climbed to meet them.

8.046 Fri, 04 Jul 9 23 Lights above cliff

Pusch Peak, Catalinas

TucsonRanger

21:39 – 0005 During the fourth of July festivities, several reports were received about lights on the west side of Pusch Peak, supposedly from hikers searching for a way down the cliffs. A couple groups of hikers were encountered by initial teams at the trailhead, not in distress and not having heard of anyone having problems. Additional groups were camped on the ridge above the waterfall. Teams covered the main trails, and one checked out the campers without finding any problems. Tucson Ranger covered the area, and the reporting parties were recontacted and advised that the helicopter was looking at the areas where the lights had been seen. So we went home.

8.047 Sun, 06 Jul 16 38 Hikers lost

Crystal Springs Trail, Catalinas

12:03 – 15:43 Two hikers reported losing the Butterfly Trail near the Crystal Spring Junction. Their cellphone coordinates plotted along the Crystal Spring Trail, and off to the east. Thunderstorms were starting as well. Deputy Torrey found their car at the Soldier's Camp Trailhead, and walked downtrail a short distance, talking to lots of hikers. Teams headed in, just after heavy rain, and one split to Butterfly Peak, running into the missing hikers a short distance over the peak. They were well prepared and doing well, and all hiked out without problems.

8.048 Sun, 06 Jul 14 17 ??ym deceased

MP 0 Catalina Hwy, Catalinas

13:30-15:43 A male was overdue from a morning walk on neighborhood trails. His wife found him deceased. We provided a short litter carry back to the residence. (This was a short call, handled by people diverted from the previous call, so no separate page was made.)

8.049 Mon, 07 Jul 11 37 3x20ym hikers lost

Romero Canyon, Catalinas

16:13 – 19:47 Three males hiked to Romero Pools and decided to return down the stream. It was longer and more difficult than anticipated, and their water supply was low, so they called for help. Cellphone coordinates suggested they were not far down, but initial teams were unable to get a response while hollering from the trail. Additional teams headed upstream from the mouth of the canyon, and met the hikers a short distance up. After providing refreshments, all hiked out without problems.

8.050 Sat, 12 Jul 13 47 3f hikers off trail

Lemmon Rock Trail, Catalinas

21:55 – 01:30 Three hikers went down the Mt.Lemmon Trail, had problems following the Wilderness of Rocks Trail, and were caught after dark near Lemmon Rock. Voice contact was made from the lookout. Teams found the subjects in good condition a short distance off trail, and all walked out without problems.

8.051 Sun, 13 Jul 13 37 2f stranded by high water

T.V.Falls, Redington Pass

15:08 – 16:53 Morning rains increased the flow in Tanque Verde Canyon, stranding a woman and her 4y daughter on the south side. Teams rigged a litter with PFD's for flotation, and ferried the girl across, followed by mom.

8.052 Thu, 17 Jul 11 32 3f hikers lost

T.V. Canyon, Redington Pass

22:06-01:00 Three women hiked up canyon from the Upper Falls Trail, but were caught by dark before finding their way back. Deputy Steve and Sgt. George hiked down from Windy Corner, finding the three well above the stream. Teams scouted routes downstream and back up to the road, and everyone hiked up without problems.
