SARCI MINIMUM FIELD QUALIFICATION

SARCI has expanded the minimum field qualification requirements for all groups to include PCSD-NIMS (formerly known as "NIMS-138") and Arizona Basic Search and Rescue training. These requirements will become effective at the end of 2014, so there is time to get anyone missing one or both up to speed. Please refer to the SARCI Field Qual Report (available on line or from Records) to see who needs to complete these classes.

The SARCI Field Qualification minimum requirements shall include all of the following:

- SARCI Orientation
- Wilderness First Aid as certified by ASHI, or equivalent
- CPR for the Professional Rescuer as certified by ARC or AHA, or equivalent
- National Incident Management System (NIMS) IS-100 and IS-700, or equivalent
- *Effective 12/31/2014:* Pima County Sheriff's Department local protocols, commonly referred to as "PCSD-NIMS" (aka NIMS-138)
- *Effective 12/31/2014:* Arizona Basic Search and Rescue as defined by the Arizona Search and Rescue Coordinators Association, or equivalent", commonly referred to as "AZ-Basic"

TRAINING AND CERTIFICATIONS

MRA Reaccreditation

SARA is required to be reaccredited once every five years in search, snow and ice rescue, and technical rope rescue. This fall, we will be doing the search and technical rope reaccreditations.

Search will be a table talk exercise, involving only a few people, in which we explain our organization and operations during one of our recent searches. This will be held at the SARA House on Friday evening, October 31. (Sorry, no trick or treating!)

To prepare for the technical rope rescue reaccreditation, the technical team will have two rehearsals, one on Saturday, Sept 20, and the other on Sunday, Oct 19. The actual reaccreditation will be on Saturday, November 1. For each of these events meet at 106 at 08:00.

All Members are invited to attend these rehearsals and the reaccreditation as observers. We do not often have a technical rescue, so this is an opportunity to see what's required to operate in a vertical environment. We will need and welcome help in carrying gear in and out of the field, and of course, rope pullers will be needed. We may also have people to volunteer to be the patient.

Technical Skills

The next Technical Skills training will be in October. If you have not attended a classroom session previously, that will be held on Wednesday, October 22, at 18:30, at the SARA House. The field exercise will be on Saturday, October 25: meet at 106 at 08:00; the exercise will be held at the Prison Camp. Pre-registration is required due to limits on class size.

As of August 22, 24 people have never taken the class, and their old field skills certification will expire on January 1, 2015.

Sixteen other people took the class in November or December of 2013, and they need to renew their technical skills certification by December 31, 2014.

Also, 37 Members qualified in January 2014, and they will have to re-qualify by the end of January 2015.

MONTHLY TRAINING

The September training will be Personal Rope Skills. This training works on basic rappelling, ascending, and edge safety skills. The training will be on Saturday, 06 September. Meet at 08:00, tentatively at 106 (though the location may change). Everyone will need their full rescue pack, as well as a commercial seat harness and a set of Purcell Prusiks. A commercial chest harness is preferred, but for those who don't already have one we will show you how to tie one from webbing.

For those who may not be comfortable with a particular skill, that is fine, everyone will be welcome to participate to their comfort level. For our newest candidates who were just accepted last week: Congratulations! We all look forward to working with you over the next several months as you work through your initial training (and hopefully years to come after that). At this point the field training would likely not be appropriate for you (even those with climbing or other rope experience) as we will be introducing topics which can confuse you during the Awareness training coming up. However, you are welcome to come to the classroom sessions outlined below to start picking up concepts that you will use later on. I look forward to meeting any of you who do attend.

We will have a full classroom session the week of 1 Sept (either Wednesday or Thursday night, I will update as soon as I get it nailed down) where we will go over tying the Purcell Prusiks, as well as discuss other important considerations for this type of rope work. The classroom session is not strictly mandatory, but is recommended if your schedule allows.

We will also have a "mini-training" ahead of the monthly meeting next Friday 05 September, where we will again have instructors available to help tie the Purcells for those of you who do not make the full classroom session. In order to tie the Purcells you will need 30-35' of 6, 7, or 8mm accessory cord (available at Summit Hut or REI, and possibly from Dave Brown). Each diameter has its own advantages (8mm being easier to slide on 11mm ropes, 6mm for being able to grab on skinnier ropes, for example). If you are only going to make one set, my recommendation is 7mm (you might get different opinions from other members, which is fine).

In order to tie a chest harness you will need 10-12' of 1" or 2" tubular webbing (again available at Summit Hit, REI, or possibly from Dave Brown).

| 15:45 – 18:35 | A male became exhausted about x5. The hasty team attended to him until a horse arrived, but he was not able to ride so a stokes ride returned him to the trailhead. | | |
| Sun Aug 10 | 21/ 58/ 60ym motorcyclist injured | Chivo Road, Rincons | RMFD |
| 12:35 – 15:15 | One of a group cycling in the Chivo area crashed with several injuries. He attempted to ride out and crashed again about a half-mile from Redington Rd. Teams found him off road in a shady spot, treated and packaged for a stokes carry to the road, and a ride in the Hummer back to Circle-K for transfer to an ambulance. He was happy that he had not been allowed to drive himself. | | |
| Sun Aug 10 | 22/ 77/ ??yf hiker missing | Butterfly Trail, Catalinas | |
| 15:25 – 19:05 | Two hikers started at Soldier's Camp, hiked up Bigelow and returned on Butterfly Trail. Above the junction with Crystal Spring, he went ahead to take some of their equipment to their vehicle while she continued slowly. He returned to meet her, but was unable to find her. Deputy Dave noted track on the side trail to Butterfly Peak, and made voice contact on the other side and down the ridge. As they hiked out, other teams and the companion joined the group. | | |
| Tue Aug 12 | 11/ 22/ 28yf (8mo pregnant) hiker ankle inj | 7 Falls Trail, Catalinas | |
| 14:20 – 15:10 | Cellphone coordinates for an injured hiker were above 7 Falls, so additional resources were requested. It turned out that they had missed one of the stream crossings well down canyon. After their call for help, trail runners helped them back on trail and they were met by the hasty team before the first crossing. She was 8 WEEKS pregnant, and did not have an ankle injury. | | |
| Thu Aug 14 | 25/ 129/ 53yf missing | Rose Canyon, Catalinas | Ranger54 Survey1 BorSAR |
| 16:35 – 01:00 | Two sisters were picnicking near the end of the road. One went for a short walk towards the northeast, and did not return. She had mobility problems and was hard-of-hearing. Teams searched along the Rose / Sycamore ridges, finding a water bottle that matched others in their vehicle. The ridge has side ridges higher than the main one, complicating her route while returning. Two teams dropped into Sycamore near the confluence with Rose and one headed upstream and the other down. The downstream team was not finding anything interesting, so were guided up into Rose. The woman was found about half-way up to the main dam, cold and complaining of having slipped and injured her back. Equipment was carried to the scene for a technical carry-out, but the canyon is very rough with lots of downfall, and it was wet. Air resources were arranged for the morning. All but a few people were released. | | |
| Fri Aug 15 | 2/ 20/ 53yf missing | Rose Canyon, Catalinas | Omaha Ranger54 MLFD RMFD |
| 01:00 – 10:50 | A Border Patrol A-Star was on a recon flight, and started by checking out our scene. After briefing the Blackhawk aircrew, they were advised that the hoist was inoperable. A BorSAR team had hiked in to assist the Blackhawk. Then they helped a lot by carrying out our equipment. Ranger54 short-hauled with a 150' line that just reached down through the trees. | | |
| Sat Aug 16 | 6/ 10/ Hikers exhausted | Romero Trail, Catalinas | GRFD |
| 12:35 – 14:25 | A female hiker was exhausted while hiking out from the pools. The hasty team heard that she was being assisted down trail, and heard that a male had hit his head at the pools and was unable to walk. They met the first group, found them doing well, left some water and continued up trail. Additional teams were asked to bring lots of fluids for several groups that were out of water. The male was met shortly, having hit other parts of his body before knocking his head on the rock. He was doing well. | | |
| Sat Aug 16 | 0/ 0/ 3y? missing | Drexel & I-10, Tucson | |
| 18:40 – 19:00 | Passers-by noticed a toddler in diapers walking alone down a street. They were unable to find the child shortly afterwards. It was near sunset, and a storm was moving in, and there were open areas nearby, so resources were quickly requested. Investigators found a child at a nearby house that matched the description, and the child's residence was a few houses away, finding that the child would wander between the two. We were cancelled, with thanks for our quick response. | | |
| Sun Aug 17 | 8/ 20/ 19yf hiker exhausted | Romero Pass, Catalinas | Sheriff1 |
| 15:50 – 18:40 | A couple hiked from the top down to Romero Pass. As they started back up hill, she was unable to continue. A hasty team was assigned to hike down (4.3mi, 2500' from Sutherland jct) and decide which way to hike out. Sheriff1 lowered a deputy to the scene, and might need to hike out with the companion. The Romero Trail (6.5mi, 3200' to old trailhead) is rougher and into the sun compared with Sabino Canyon (9.3mi, 2600' to Stop9). Pick your poison. A support team started in from Stop9. All were turned around when Sheriff1 had picked up all three people. | | |
| Sat Aug 23 | 10/ 20/ 62yf hiker fall injury | Romero Trail, Catalinas | Sheriff1 GRFD |
| 15:15 – 17:25 | A female hiker rose from a rest, fainted and hit her head. She was hoisted by Sheriff1 and delivered to the helipad. | | |
| Sun Aug 24 | 11/ 30/ 57ym hiker ankle injury | Romero Trail, Catalinas | GRFD |
| 11:45 – 14:30 | A male hiker injured his ankle near the spot from the previous call. He was carried down by stokes. | | |
| Sun Aug 24 | 18/ 72/ Hikers with ankle injuries | Tanque Verde Canyon, Catalinas | Sheriff1 RMFD |
| 14:15 – 18:30 | A female had rolled a rock over her ankle, and she was unable to continue up the loose slope. She was found in the Main Falls Chute below the helispot. As we prepared for a hoist, another call was received about an exhausted female in the canyon bottom downstream. A team hiked down the SARA Trail, and worked with Sheriff1 to locate her. The team assessed while the hoist was done with patient#1, then they wound up hoisting patient#2. Companions (with dogs) came out with the teams. | | |
