SARCI MINIMUM FIELD QUALIFICATION

SARCI has expanded the minimum field qualification requirements for all groups to include PCSD-NIMS (formerly known as "NIMS-138") and Arizona Basic Search and Rescue training. These requirements will become effective at the end of 2014, so there is time to get anyone missing one or both up to speed. Please refer to the SARCI Field Qual Report (available on line or from Records) to see who needs to complete these classes.

The SARCI Field Qualification minimum requirements shall include all of the following:

- SARCI Orientation
- Wilderness First Aid as certified by ASHI, or equivalent
- CPR for the Professional Rescuer as certified by ARC or AHA, or equivalent
- National Incident Management System (NIMS) IS-100 and IS-700, or equivalent
- Effective 12/31/2014: Pima County Sheriff's Department local protocols, commonly referred to as "PCSD-NIMS" (aka NIMS-138)
- Effective 12/31/2014: Arizona Basic Search and Rescue as defined by the Arizona Search and Rescue Coordinators Association, or equivalent", commonly referred to as "AZ-Basic"

Sun Sep 07 10/28/2 hikers stranded by dark Montrose Canyon, Catalinas Survey1

20:40-23:20 Two hikers in Montrose Canyon were stranded by dark in a rough canyon. It looked easy to retrieve them, so a limited response was requested. The hasty team had to work their way off trail, around cliffs, but found them near their cellphone coordinates. Other friends were also looking for them, so it was interesting sorting out the responses to shouting. All returned without problems.

Sun Sep 14 0/ 0/ 23yf hiker exhausted SARA Trail, TV Canyon, Rincons RMFD

14:25 – 14:34 One of a group was reported having seizures in Tanque Verde Canyon near the SARA Trail. They assisted her to the road by the time officers arrived. One of them drove the patient for evaluation to an ambulance at rendezvous.

Wed Sep 17 <u>0</u>/ <u>0</u>/ 4yf missing Drexel / Palo Verde, Tucson

18:51 – 18:53 A young female was reported missing, so lots of resources were quickly requested. She was found under a trailer.

Sat Sep 20 8/ 19/ 16yf fall injury "The Crack", Sabino Canyon, Catalinas TucsonRanger RMFD

10:35-12:45 A female attempted to jump into the pool, landing on her rear end and bouncing her head. She was short-hauled to a team at Stop 8 and transferred to an ambulance.

Sun Sep 21 <u>12</u>/ <u>19</u>/ 65yf exhausted Sabino Canyon, Catalinas RMFD

12:50-14:20 A woman walked from the end of the road down into the canyon, and was unable to return in the heat. She was met about half-way up the social trail and carried by stokes to the road. The ambulance evaluated her at the back gate.

Tue Sep 30 7/ 12/ 52yf hiker lost Starr Pass, Tucson Mtns

17:00 - 18:20 An out-of-town woman was unable to follow a trail, and called for help. The Hasty Team walked from the end of the old road past the ClearWell Reservoir a short distance to the trail junction in the saddle, and made voice contact. A short cross-country traverse got to the woman who was in good condition, and all walked out without problems.

Sat Oct 04 8/35/45yf hiker off trail Mt.Kimball, Catalinas Sheriff1

16:05 – 20:35 An inexperienced hiker made it to Kimball with guidance from a cellphone map. On her return, she wasn't paying close attention and walked past the junction, continuing on the Pima Canyon Trail, losing it, then heading for the trail visible across canyon, and calling for help when she reached the top of the main cliff band. Sheriff 1 hoisted Dep.Boll down, and her up and delivered her to the SARA House but was unable to return for Brian. He was guided to the trail and met the backup team at the "Corner", and all returned without problems.

Fri Oct 10 9/ 19/ Two hikers stranded Sycamore Canyon, Catalinas Sheriff1

13:00 – 16:00 Two men who had hiked Sycamore Canyon several times as boys, returned from their jobs in Texas to hike it again. The Aspen Fire burned the trees, the wind pushed them over, so scrambling down canyon was exhausting. The stream was running well, so they were well behind the three days allotted. Then it rained. A lot. On the fifth day they ran out of food and energy and were still only 34 of the way to Sycamore Basin. Sheriff 1 hoisted Dep.Boll to the men, hoisted one and delivered him to Prison Camp, then hoisted the other hiker and Brian.

Sun Oct 12 10/ 59/ 21ym hiker exhausted Romero Trail, Catalinas

18:40 – 01:20 Two hikers started on Mt.Lemmon. One was experienced and fit, the other wasn't and pooped out just below Romero Spring. They continued down trail in the dark, stopping and making a fire at the 3rd crossing. The hasty team found them, fed and watered the hiker, ankles taped for support, and hiking poles provided. He had lots of company for the slow hike down.

Sun Oct 19 <u>0</u>/ <u>0</u>/ 34ym missing Campground, Catalina St.Pk, Catalinas

02:40-03:10 A male was missing from a family group. He was located by family before volunteers arrived. A second call was brewing in Molino Canyon, but the missing subject appeared while the investigation was in progress. Go back to bed.

Sun Oct 19 11/ 34/ 47ym depressed Linda Vista, Catalinas Survey1

23:00 – 03:15 Oro Valley PD found the vehicle of a male reported missing. Survey 1 found the subject about a mile up the Pusch Peak Trail. As the lights of officers approached, a gunshot was heard. A team of SAR volunteers was requested to help recover him.

Mon Oct 20 11/22/58yf hiker ankle injury 7 Falls Trail, Catalinas

11:55 – 14:15 A female hiker injured her ankle at crossing 5 on the 7 Falls Trail. She was carried out by horse.

Fri Oct 24 8/43/ Hunters lost Turkey Creek, Rincons

15:10-21:00 Two hunters were lost in the Turkey Creek, Happy Valley area. They had been without food and water. The hasty team found them at their cellphone coordinates. A daughter had been heard hollering in the area, but uncertain whether she was also lost. The second team ran into her on the trail a short distance from the trailhead. After rehab, they were able to hike to the trail to join other teams and hike out.
