Ground Team members from the CAP Neotoma Composite Squadron worked side-by-side with multinational armed services personnel locating and assisting more than 75 mass casualty victims driven into the forest surrounding Flagstaff by a mock flood during two days of the 2015 Angel Thunder training exercise in June. Squadron Commander and EMT Lt. Col. Robert McCord and the K-9 SAR team of 2Lt Nancy Smith and canine Juliette were among more than 15 members of the CAP Arizona Wing Ground Team that were airlifted in a Chinook helicopter from Mesa's Gateway Airport to Camp Navajo outside Flagstaff to locate and triage mock victims of a hypothetical major storm flooding the area that left residents of the imaginary country of Valsura stranded in the wilderness. The Northwest Tucson CAP volunteers were part of a team of nearly 100 volunteers and paid professionals from the U.S., Dutch and German armed services as well local area fire, search and rescue squads and sheriff officials who participated in the nation's largest such SAR exercise.

The CAP Arizona Wing Conference was held in Tucson in June. Lt. Col. McCord was recognized as Ground Team Leader of the year for the wing, and it was announced that the Arizona Ground Team was awarded the Colonel Dion E. DeCamp Ground Team of the Year for both Southwest region and the nation. Members from around the state convened to hear multiple briefings, including plans for operational expansion for CAP as well as future expansion of the Angel Thunder training program.

K-9 teams Lt Col Andrea Mullen/canine Delta and 2Lt Nancy Smith/canine Juliette completed a three-day cadaver dog seminar at the forensic anthropology department of Western Carolina University in May, where they met with SAR dog handlers from across the country for training in full-body human remains detection at the university's Forensic Osteology Research Station (FOREST). The course also offered training in identification of smaller specimens of ancient bones 1,500 years old as well as locating human remains in water. Lt Smith also completed the two-day Bone Identification course to aid in distinguishing human from animal bones in the lab and in the field.

The Civil Air Patrol's Neotoma Squadron actively participates in ongoing search and rescue missions and training exercises at the state, local and national levels. We welcome new members to join the more than 700 members of the nationally recognized emergency services Arizona Wing Ground Team. **Training:** Mule Power Farms night training June 6. We had Dr Woodard from Reata Vet Clinic come in and present a excellent clinic on Equine medical issues and animal emergency care. Even showed us how to start an I.V. on a horse. Kathryn Wade used her horse. The only taker was Deputy Brian Boll, who started an I.V. on a horse. He is our new in field I.V. started for Equine.

Next was in the field at night. Ended about 10 p.m. The training went as well as anyone could expect. Herget set the scenarios far enough apart that we had to ride to get there. Colleen, Kay and Larry Caugh were the patients and on the ground instructors. Then we had two instructors/ observers in the saddle. Deputy Brian Boll operated command. He duplicated what he would need in the field via radio with three active scenarios at the same time. Excellent Job. To describe the night training, A HOME RUN. Could not have gone better. We did find a couple of weak spots (training) that we have since trained thru thanks to Deputy Boll. A huge thanks to Joe Trueba Mule Power Farms and Larry Caugh for setting the location. It takes a lot of room and a safe place to stage a full night training for SAMSAR. Thanks to all SAMSAR members attending.

**Combined Training:** Nearly a dozen SAMSAR volunteers and more than fifteen SARA "groundpounders" trained together at the Mule Power Farm on July 12, 2015 to enhance and improve their skills in aiding and assisting injured or impaired hikers. The exercise was the first joint training venture for the organizations although they frequently work together in searching for and rescuing hikers overcome by heat, thirst or injuries in southern Arizona parks and trails. Also attending was a contingent of four volunteers from the Cochise County Mounted Rescue organization which is exploring a reorganization of their group to provide more skilled and better trained rescue personnel to the Cochise County Sheriff's Department. Led by Colleen Leon and Jerry Simmons, SAMSAR members provided their well-trained steeds to assist in educating SARA ground-pounders in the "dos and don'ts" of working with equines in search and rescue missions. In addition to rescue equine "etiquette" -- always approach an equine so he can see you, stay away from the caboose area, and don't open and shake a thermal sheet in the equine's face -- volunteers were informed of more subtle idiosyncrasies of equines: "The ears tell the story. The sound of an empty water bottle being crushed and crackled drives them crazy. An annoyed equine can deliver a well-placed hoof forcefully even to someone standing next to it."

The participants also received hands on instruction on lifting an injured patient on and off a rescue equine. This essential skill training involved putting splints on some volunteers and hoisting them onto an equine. "It's much harder than you guys in SAMSAR make it look." remarked one of the SARA participants. There is, indeed, a technique involved in surrounding a 1000 beast with four volunteers and a usually apprehensive injured patient into a western saddle. The training involved organizing the caravan of ground-pounders and equine handlers for the trek to safety and avoiding the rescue victim falling out of the saddle or sliding off to one side. The process of dismounting a victim from an equine at the trail-head is equally important and also was practiced.

The training session ended at noon, after about four hours, and the heat of the day of much relieved by the refreshments and sustenance so graciously provided by Brett and Rosemary Hinch, co-owners of Mule Power Ranch.

Members of both groups remarked on the benefits provided by the joint training exercise and expect that other joint training exercises will be scheduled in the future on other subjects.

## SARCON 2015 REPORT

Four SARA members attended SARCON 2015, the joint MRA/NASAR conference held June 4 ó 7 in Estes Park, Colorado. The conference consisted of numerous presentations on topics of SAR techniques and standards, including wilderness medicine, developments in technical rope rescue, cave rescue techniques, radio communications, leadership and SAR response coordination, and dog team training and search tactics. The significant outcomes of the MRA business meeting were a vote in favor of authorizing a committee to research and acquire a comprehensive insurance policy covering the Mountain Rescue Association, and a discussion on expanding a pilot program to provide scholarships for first time attendees to an MRA conference.

The conference and MRA meeting provided an excellent venue for SARA members to enhance relationships with fellow MRA teams and discuss industry standards and best practices. Attend the August SARA monthly meeting for a presentation about conference takeaways ó including best practices in wilderness medicine for treating hypothermia and altitude sickness, developments in technical rescue, and communications issues and strategies ó and a discussion about the MRA business meeting.
