#### **SABINO CANYON PARKING**

### **DPS "Screamer Suit" REPLACED**

DPS Air Rescue has replaced the Bauman "Screamer Suit" with the AVED "A-ved", Ambulatory Victim Extrication Device from Priority 1 Air Rescue (<a href="https://prioritylairrescue.net">https://prioritylairrescue.net</a>). The Screamer and AVED are very similar. Yates and CMC Pro offer similar devices, with very different prices. All of them are rated for up to 400 lb loads. Ms.Bauman has retired, so has the Screamer.

The AVED uses a Cobra quick-release buckle on the waist strap, rather than a plastic buckle. The middle strap (between the legs) is adjustable. Wearing and connecting the AVED to the short-haul line is very similar, but will normally use two carabiners.



#### **COVID-19 MITIGATIONS**

In order to help mitigate the spread of COVID-19, the Board directs that SARA suspend all in-person activities not related to missions (trainings, meetings, etc.) until May 15 2020. Exceptions will be subject to Board approval.

Due to the potential impact of this directive on re-certification opportunities, SARA will freeze field qualification (FQ) status through June 30. During this time, a field qualified member with an expiring FQ-required certification will remain eligible for deployment in the field, upon approval by the mission IC, but will need to address any expired certs by June 30.

The Board will continue to monitor developments, and this directive may change as conditions warrant.

#### **RESPONSES DURING COVID TIMES**

During this time of COVID-19 and social distancing, there is a modification to the standard response to a request for a mission. While typically when a request for a mission is put out, we allow all members who respond to attend the mission, some items will change now that we are in COVID time.

For missions that do not require a large number of responders, the deputy requesting the alert will work with the SARA member putting out the page to come to a number that is reasonable for the mission. For example the search at Pima Canyon the other night would probably been limited to 3 field people and an Ops vehicle. It is understood that not all missions have the required info up front to determine the number of responders needed.

In the case where additional resources are needed, a page requesting additional assistance will be put out. If the request is for 3 people, the desire is not to have the first 3 people that respond, but that the responses be the first 3 that are in close location to the rendezvous.

If no number is specified in the alert, it is assumed to be a normal call for any available resources.

Before responding, you can check the list of responders to see how many people have already responded.

#### SARA BOARD – POLICY CHANGE

I hope you are all doing well and staying healthy. This note is to notify you of a proposed SARA policy change prompted in part by the COVID-19 situation and to invite your feedback on this change. One of our recent modifications to the policies was to modify item I.F.5 to read:

#### I. Membership

- F. Qualifications
  - 5. Outdoor Emergency Care (OEC) will be accepted as a medical training for field qualification for Candidates and Rescuers until July 1, 2020.

This is the statement in the current membership policies as approved on 11/21/2019, and also appears in the most recent revision approved on 3/19/2020.

As a result of the effect of the COVID-19 on our training schedule and to officially extend the sunset date for others affected by previous policy changes, the board proposes the following change to item I.F.5 of the membership policies:

#### I. Membership

- F. Qualifications
  - 5. Outdoor Emergency Care (OEC), Wilderness First Responder (WFR) and Wilderness First Aid (WFA) will be accepted as a medical training for field qualification for Candidates and Rescuers until December 31, 2020.

Since this proposal constitutes a change to SARA's Membership policies, the proposal will be presented for member comment at the next two SARA monthly meetings per our policies, to be followed by a Board vote on the proposed policy change.

Your feedback is welcome. You may email feedback directly to me or to the SARA Board of Directors. You will also have the opportunity to provide feedback in person at our May and June SARA monthly meetings. Details regarding the format of those meetings will be sent soon.

#### SARA MEDICAL DISCUSSION

As you know, the Medical Committee and many members of our organization have been working diligently to ensure that all OEC medical certified Rescuers will be able to bridge to the EMR medical certification as required by the Pima County Sheriff's Department. Effective March 19, 2020, this recommendation has been accepted by a vote of the Board of Directors.

While this original bridge course applies to the majority of our members, please know that we will work with whoever needs it to get this accepted certification to be retained within the group. All of our members are important to this organization, and we do not want to lose any one of you during this transition.

There are still some questions within the transition process yet to be answered, but these are being worked on for an acceptable resolution to our members. Speaking on behalf of the Board, I want to thank the Medical Committee and other members who have dedicated a considerable amount of time and hard work to ensure that we meet these new standards.

Also during the March 19 Board of Director's meeting, Dr. Nicola Baker was voted in as the new SARA Medical Director. Dr. Baker is a previous SARA member, and currently works as an Emergency Physician and Assistant Professor at Banner University of Arizona Medical Center. She is an avid outdoorswoman, and a Fellow of the Academy of Wilderness Medicine through the Wilderness Medical Society. Dr. Baker will be introducing herself to us, however due to the current COVID-19 pandemic, the introduction will be made via email.

In her role as SARA Medical Director, Dr. Baker will work with Dr. Kastre, who is going to remain with the PCSD SAR Unit. As with all medical providers during this time, some of whom are our own SARA members, they are confronted with an increasingly strained healthcare system. We want to express our greatest appreciation for their efforts as they fight for the health and safety our community on the "front lines."

## SARA BOARD – UNIFORM SHIRTS

SARA Members are reminded that SARA has budgeted to provide uniform shirts. Please check with the SARA Store for details. While meetings are suspended, send your requests for information to *Records @ sarci.org*.

- 1. The blue dress shirt embroidered with your name and the SARA logo is available for members that interface with the public.
- 2. Recognized field uniform shirts are available to active Rescuer, Candidate and Basic members. You may qualify if you have not had one issued, or yours is showing the wear of many missions. Recognized shirts generally include:
  - T-Shirts stocked in SARA Store
  - Orange button down shirts with embroidered name and SARA logo
  - Orange 'Tru-Spec' military style shirts with Velcro name and SARA logo

Below are the medical training currently being offered by the SARA Medical Committee. These training are open to members of all SARCI component groups plus the Caver SMEs. Advanced registration via Whoozin is required for all classes to ensure sufficient instructors / materials. If sufficient registrations are not received by one week prior to the class, it may be subject to cancellation. All training will be held at the SARA House.

Cardio-Pulmonary Resuscitation (CPR): See the AHA guidance on the next page.

**Wilderness First Aid (WFA)**: For those needing WFA, the following sessions are scheduled. Minimum 4 students needed to host the class. There are no fees or required materials for this course. Weekday sessions will be held from 18:00 - 22:00 and Weekend sessions from 08:00 - 17:00.

No WFA classes are currently scheduled

**Blood Borne Pathogens (BBP)**: It is an AZ state requirement that all search and rescue volunteers take an OSHA BBP class once per year. Eventually members will be able to take this online on the SARA website, but until this system is available we will continue offering in-person classes.

No BBP classes are currently scheduled

**Naloxone Administration**: Due to the nation-wide opioid crisis, the State of Arizona recommends all first responders be trained in the administration of Naloxone. SARA offers this optional training to all SARCI members free of charge. To remain current it is recommended rescuers re-take this training once every two years.

No Naloxone classes are currently scheduled

**Wilderness Emergency Medical Responder (WEMR)**: Dates for the upcoming WEMR class are TBD. Classes will be on Tuesday / Thursday evenings from 18:00-22:00 every week with three all-day Saturday classes. Registration will be open once the dates are finalized.

# UPDATED: Interim Guidance on Card Extensions during COVID-19 Outbreak



## CPR & Emergency Cardiovascular Care

## March 31, 2020

Purpose: To provide additional flexibility for providers, AHA Instructors, and Instructor candidates during the COVID-19 pandemic. NOTE: This guidance on card extensions supersedes the guidance outlined in the March 13, 2020, document, "Interim Guidance on Extensions for AHA Instructor & Provider Cards during COVID-19 Outbreak."

#### AHA Instructor and Provider Card Extensions

Per the statement regarding further extensions of AHA course completion cards beyond 60 days past the recommended renewal day (in interim guidance released on March 13, 2020), and given the ongoing threat of exposure to COVID-19, with many communities under shelter in place orders to minimize the spread of the disease, the AHA is extending AHA Instructor and Provider Course Completion Cards for 120 days beyond their recommended renewal date, beginning with cards that expire in March 2020.

Please see the AHA's guidance below, and disseminate to anyone who has a business need for this information (e.g., students, employers, medical or safety regulators, etc.).

## For Instructor Cards expiring beginning in March 2020:

- AHA Instructor cards will be valid for 120 days beyond their recommended renewal date.
- Instructor candidates will also have 10 months from the completion of their Instructor course to complete monitoring.
- Management of this extension, and any record-keeping, will be the responsibility of the Training Center.

#### For AHA Provider Cards expiring beginning in March 2020:

- AHA Provider Cards will be valid for 120 days beyond their recommended renewal date.
- Management of this extension, and any record-keeping, will be the responsibility of the Training Center.

## AHA Policy on Expired Cards for Update/Renewal Courses:

 Over the next 120 days, for providers whose cards have expired due to inability to complete training during the COVID-19 outbreak, the AHA will allow Instructors to provide remediation during update courses. Date

12:40 - 13:20 An injured hiker was carried to the road by stokes.

Tue Apr 07 12/ 37/ 12ym hiker fall injury 7 Falls, Bear Canyon, Catalinas Sheriff1 RMFD

12:10 – 13:20 A boy jumped towards a pool, landing stiff-legged on his feet on rock, and complained of back pain. He was carried by his father to x7 where Sheriff1 hoisted him to the Overlook LZ. The hospital discovered a stable L1 injury.

Sun Apr 12 24/151/22ym MVA recovery MP 13.5, Catalina Hwy, Catalinas Survey2 MLFD RMFD

*No field times* A driver lost control, crashing through the guard rail. He was ejected about 400' down slope and the remains of the vehicle went another 400'. He was hauled up to the road. Lots of rope used, and lots of people from several agencies.

Sun Apr 12 20/ 74/ 60yf hiker missing Gates Pass, Tucson Mtns Survey2 Sheriff1

17:30 – 19:20 Two women were hiking up the peaks north of Gates Pass when one injured her ankle. The other was carrying a dog that had got into cactus, so she carried the dog back to the parking lot and returned with companions, but the injured woman was missing. Teams covered ridges and drainages with Survey2 looking from above. Sheriff1 responded and found the woman at the base of the slope on the west side. She was hoisted to the Old Tucson parking lot.

Wed Apr 15 12/ 14/ 21ym hiker ankle injury Lizard Rock, Catalinas MLFD

*No field times* A male injured his ankle on Lizard Rock, and initially looked like he would not be able to walk. By the time teams were on their way up the highway, Mt.Lemmon Fire had escorted him to the road.

Fri Apr 17 7/ 30yf hiker ankle injury Bear Canyon, Catalinas

No field times A female hiker injured her ankle. She got out before teams arrived.

Sat Apr 18 16/72/19yf hiker ankle injury TV Canyon, Rincons Sheriff1 RMFD

12:15 – 14:30 A hiker injured an ankle while near the stream. She was hoisted to Emily Gray Junior High School.

Sun Apr 19 14/ 55/ 20ym hiker exhausted Romero Pools, Catalinas GRFD

10:35 – 12:25 A hiker was exhausted as his group approached Romero Pools. He was given fluids and food and hiked out.

Sun Apr 19 3/2?ym hiker out of water Romero Pools, Catalinas

No field times A hiker called for help when he did not have water for his hike out. SAR was cancelled after he found water.

Wed Apr 22 4/ 5/ 2 20yf hikers without light Romero Canyon Trail, Catalinas

No field times Two hikers without lights called for help from about Saddle1. They were met on the road.

Sat Apr 25 17/ 33/30ym hiker ankle injury Phoneline and Blacketts Ridge Tr, Catalinas

11:55 – 13:00 One of three hikers coming down from Blacketts Ridge injured his ankle. He was assisted to the Phoneline junction where the group requested help. His ankle was splinted, and he was carried to the trailhead. Meanwhile, a call for a separate incident was received from Bear Canyon. The subject was found at the old trailhead.
