BOARD OF DIRECTORS – MEMBER SURVEY

We have spent weeks digesting the results from the member survey. Thank you very much for the feedback. While the goal of the board is to attempt to address all issues, we will begin by focusing on the areas that need the most work. I would like to share our initial plan which will exist as an ongoing board agenda item.

Rework Mentor Program (Increased Retention):

- Increase mentor count and include board members if desired
- Make it a team of mentors instead of individual assignment
- Earlier face to face with the SALT class of mentors
- Continue with the Candidate feedback program and refresh rescuer memories about filling it out for Candidates.

Increased Member Survey Frequency (Increased Retention/Mission Participation):

- Annual Full Member Survey (Summer 2024) Take comments related to survey suggestions in the 2023 survey in mind to revise the next Annual Member Survey.
- Create a separate Candidate specific survey.
- Track results for annual comparison to find trends.

Board Effectiveness (Mission Participation/Increased Retention/Quality Training):

- Add a Board Minute to the general meeting to briefly note the highlights from that month's Board meeting.
- Publish Board goals annually to the membership.
- Use the Annual Survey as one method to identify whether some goals were achieved or could be improved upon. If the Annual survey is in the summer, the annual goals could be published each fall.

• Each Director and committee Chair should put together a succession plan for any that take on the role they are in.

Include new members in activities and taking a leadership role (Increased Retention/Quality Training):

- Encourage people who step up.
- Remove barriers for candidates who wish to participate earlier.

This is not a comprehensive list of improvement areas from our survey. We feel that addressing these issues will positively impact many other areas. Everyone is encouraged to attend board meetings every third Thursday at 19:00 for updates. A link to the Teams meeting is in the Master Calendar.

FIELD COMMUNICATIONS DIRECTION

We've had a couple of recovery missions this year that have prompted some discussion with PCSD about how our findings are communicated. In the past we have used "310F" when referring to the subject of a recovery operation. Effective immediately SARA will be using the verbiage "Code 900" when referring to a deceased subject that is found during a Search or Rescue. This is what PCSD uses and will prevent any confusion and ambiguity among all teammates about what is happening and what our findings are. When we hear "Code 900" on the radio on a mission, all teams should stop where we are at and await further instruction. Do not get on the radio asking for information about the mission or the findings. Wait for direction from IC or Operations at that point.

Furthermore, remember that any scene with a deceased subject should be treated as a crime scene. Any disturbances to the scene by anyone should be minimal-to-none except at the direction of IC or Operations.

We'll keep this radio code change in mind when training the next SALT class.

INCIDENT MANAGEMENT TEAM

In-person introductory classes for those interested in the IMT planning function will be held of successive Monday evenings on 24 April and 1 May, from 18:00 – 22:00. The classes are open to anyone with no experience, to those wishing to refresh their knowledge. They will be taught by Chris Yamanaka and members of the IMT Team. Topics to be covered, in order, include Initial Response Organizer (a computer application program for recording data during operational period zero), WinCasie3 (a computer application program useful for continued data recording and transitioning from a route and location search to an area search and its statistical management), SARTOPO (a mapping program useful for search segmentation and searcher tracking), and finally a brief search exercise. The presentations will be spread across the two evenings, breaking where appropriate dependent on how much is covered the first evening.

HOLLIN BASIN/HARLAN CANYON

The challenge for March was to hike into a canyon and through an area known as Hollin Basin. The ERM Catalina POI map calls this Hollin Canyon at present, but some of us have been calling it Harlan Canyon, in honor of Tom and Anita Harlan.


Tom and Anita were part of a college hiking club called the Roma Ramblers. In the late 1950s or early 1960s, they became members of SARA and participated in many SAR missions.

The Lord of the Rings trilogy by J.R.R. Tolkien was published 1954-1956 and quickly became a cult classic. Tom and Anita and their friends from college camped in a flat area of this canyon that they named Hollin Basin after a location in Middle-Earth, the fantasy world created by Tolkien. Reportedly, they even acted out scenes from the books while camped there. (The world had not yet been overrun by computer games, so people were still free to use their imaginations.)

Tom was a field researcher for the University of Arizona Tree Ring Research Laboratory. He worked all over the west, collecting sample cores from trees; that research helped to establish the chronology of human habitation in the western United States. He was one of the nicest people I've ever met and hiking with him was like a field course in botany. At times, it seemed like he knew the trees not only by genus and species, but by individual name. Gordon and I once found a very large pine tree with a metal tag near Lizard Rock, indicating that it had been cored. I asked Tom if it was the largest tree in the Catalinas, and he replied that it was the largest one that he knew about. As far as I'm concerned, that's definitive.

I have been thinking about submitting an application to the US Board on Geographic Names or the Arizona Board on Geographic and Historic Names to have this canyon officially named Harlan Canyon for Tom and Anita. That might include requesting a letter in support from the Board of Supervisors and/or getting letters from local residents.

In the meantime, enjoy your hike down (or up) Harlan Canyon, working your way around the 11 waterfalls that were large enough to be waypointed. The canyon runs generally north-northeast to south-southwest. It begins at approximately 12S 0529701E 3581382N (32° 22.36', -110° 40.59') and ends at its junction with Molino Canyon at approximately 12S 0529020E 3577790N (32° 20.20', -110° 41.49'). The usual place we've entered the canyon is about 12S 0259335E 3580660N (32° 21.75', -110° 41.29').



SARA TRIBUTE TO MEL ZUCKERMAN

It's important that stories are preserved. Early on in SARA's fundraising efforts for the SARA House, a meeting was arranged by one of his employees who was a SARA member. During that meeting, he asked our intentions, which were to raise sufficient funds to build and endow the maintenance of our building. The goal was to do it once and not saddle future SARA members with additional fund raising, as we joined by and large to do search and rescue. He looked across his desk and said that the endowment would be the hardest money to raise and that once the building was complete he would give us \$100,000 for the endowment. It was SARA's first pledge.

The story doesn't end there. Early attempts at building design by amateurs weren't progressing and he stepped in again to put us together with one of his architects that designed the building you see today.

When various high-net-worth individuals were brought together for a fund-raising lunch, he joined in and added an additional \$50,000 toward construction which was a major catalyst for others around the table.

At the building dedication, he cut the ribbon on the door and was presented with his own key to the building.

ACCORDING TO HISTORY – THE USE OF HAM RADIO

It may seem to present day search and rescue volunteers that the use of Ham Radio is a latter day communication improvement. Before we started using it a lot, in the last few years, we were limited to a small number of base and mobile units, licensed to SARA, with only two simplex frequencies, each, RESCUE and MRA. Before that, we used one of the Sheriff's frequencies that they called, 'F-1' or 'OH-FOUR', (155.040 MHz).

However, for 'The First Search' in November, 1958, the first news that help was needed and the first base camp communication to Tucson and to teams in the field was via Ham Radio. I remember hearing, over and over, the Amateur Call Sign, "Double-U--Seven--Dog--Mike--Easy--Portable Seven. Dick Oaks, W7DME, had set up portable equipment in the lobby of the old Santa Rita Lodge and was functioning as "Field Net Control" for the Catalina Emergency Net. (Reference: "The Madera Canyon Report", CQ Magazine, May, 1959, as reprinted in ZERO BEAT, April, 1994.)

Communications with the field units did not always work. I remember our team leader being handed a portable radio and given quick instructions as to how and when to use it. ("...synchronize your watch and check in every half hour, 15 minutes before and after each hour...") The first radio check, from the parking lot, worked, but one-half hour into the field it did not. After all, the Field Net Control Operator had to watch his watch and listen for the faint signal from the field by tuning his receiver with a variable capacitor.

When Tom, Don and Eber reached the top of Old Baldy (Mount Wrightson), on Tuesday afternoon, they searched for the victims in a shelter spot under the floor of an old lookout cabin. They used an un-prearranged negative gesture to a military fixed wing aircraft circling overhead. Their message was relayed to The Santa Rita Lodge via the control tower at Ft. Huachuca, Pima County Communications in the Old Court House, a radio equipped patrol car at the county line (also the snow line), a mobile Ham unit parked along side, and finally to base camp.

Dick Oaks was finally relieved as control operator on Wednesday afternoon by a communications specialist from Ft. Huachuca. Dick was very tired. There was a moment when he did not think his instructions were being understood by his relief. I did not understand the significance of their exchange at the time, but I remember their facial expressions when the specialist put his hand on Dick's shoulder, indicated that he was also a Ham, and said, "...get some rest." Only after that did Dick do as advised.

Watch this space for the origin of the 'One-Wheeled-Stokes'.

About the Author

While attending high school in Tucson, in Pima County, Arizona, Marvin Stafford got his start in Search and Rescue as a member of a Boy Scout Explorer Post which called itself a 'Search and Rescue Post'. They practiced first aid, mountaineering, and some simple technical evacuation procedures. They did not get much business as there was not a mechanism in place for volunteers to assist the Sheriff's Department with their responsibility. When a major search incident occurred, involving three fellow Boy Scouts, in November, 1958, the post played a significant role. Marvin joined the Southern Arizona Rescue Association, as soon as he was old enough, in 1960. While an undergraduate engineering student at the University of Arizona, Marvin's summer job was with the Forest Service doing fire control work in the mountains near Tucson. There, he did SAR work in a Forest Service uniform; a qualified volunteer team was not yet a reality. INDOOR TRAINING SAFETY GUIDELINES (2022/01/14)

This document presents the safety guidelines that shall be implemented for indoor training during the COVID-19 pandemic.

Before Class Health Screening:

If you have any of the following conditions please consider not attending the event:

- Fever (Temperature of 100.4 or greater) plus cough and shortness of breath/ difficulty breathing _
- _ Chills

_

- Congestion or runny nose _
- Muscle pain _ Sore throat

During Class Precautions:

The following precautions will be used during time in the classroom:

- Maintain social distancing of 6 feet or more when possible
- Genuine N95 or KN95 masks shall be worn _
- Reminders will be given to wash or sanitize hands

Mask Care:

- Replace when soiled, wet, or damaged _
- When not in use, store/dry in paper bag

Hands on Scenario Precautions:

- _ Masks and eye protection will be required
- Nitrile gloves will be used and changed in between patient contacts


Classroom Hygiene:

- All equipment and indoor surfaces used will be cleaned and sanitized after/between use _
- Tables, chairs, equipment will be sprayed down with disinfectant before/after training _
- All unneeded equipment and furniture will be kept separate and clean _
- Medical equipment will be disinfected between patient contacts _
- Instructors will thoroughly wipe down and disinfect surfaces after class _
- During indoor meetings or trainings air vent fans will be set to "On" throughout the building. _

Post-Training COVID-19 Exposure or Diagnosis

- Should a student develop symptoms or receive positive COVID-19 test results within 14 days after attending training, it is recommended that they notify the Medical Chairs (SARAMedical Chairs@sarci.org) and advise of their current symptoms and/or positive test.
- Should the Medical Chairs become aware of a student with symptoms/positive test, the Medical Chairs will work _ with that student and/or Records to determine what trainings or calls that person attended in the previous 14 days.
- The Medical Chairs will contact persons who attended the same trainings as a person reporting positive symptoms/test _ results in the past 14 days and advise that they may have been exposed to someone with COVID-19 and should contact their doctor should they develop symptoms or have any questions. Persons will be advised of what symptoms to watch out for (above) and to get a COVID-19 test if necessary. The identity of the person reporting positive symptoms/test results will be kept confidential and will not be shared with training attendees.
- Persons who develop symptoms and/or receive a positive test should follow current isolation recommendations, as directed by ADHS. They will be permitted to attend trainings/calls once the recommended isolation period and time since last symptoms have been satisfied.
