MONTHLY TRAINING

EQUINE ORIENTATION AND TRAINING

SAMSAR is hosting SARA members for an equine training Saturday, March 30 at 09:00 at Tanque Verde Stables (11099 E. Glenn Street, Tucson - inside Bel Air Ranch Estates). This training will focus on how to safely interact with SAR horses, how to hand equipment to SAR personnel on horses, and how to load/unload patients from the horses. Please wear your SARA shirt and bring your rescue pack.

This training is strongly recommended for all candidates to understand how SARA and SAMSAR work together in operations involving horses and to become comfortable working around them. It is also recommended for all those who have not yet had this training. Please [Sign Up Here](#).

OFF-TRAIL MOVEMENT

The monthly training for April will be Off-Trail Movement. For new candidates, this is a specific sign-off on your orange card and is typically offered once per year. For remaining members, this will be an expansion on previous iterations of trainings on this topic in light of recent situations on missions involving preventable near-misses with rock fall and other hazards resulting from unsafe conditions. Further, "Advanced Off-Trail Movement" was a suggested topic in last year's monthly training survey and some key bullet points from that input are being incorporated as well, all in the interest of promoting increased safety for our members and subjects.

This training will be held at Catalina State Park, which is also an exciting new development since we have not yet held a regular training event in the park despite a significant call volume. We will be working in the area of Buster Mountain due to the diverse terrain and conditions it offers while being out of the way of the busier areas of the park. SARA members will need to identify themselves as such at the ranger station to avoid being charged entry fees and we will stage at the very first parking lot which is located just past the turn-off to the campgrounds next to the Bobcat Amphitheater. To minimize our disruption on the park and out of consideration for the waived entry fees, carpooling is appreciated (especially for those who may be coming from the east side). We also ask that you please [RSVP](#) so we can notify the rangers of our expected headcount.

What: Please wear your SARA shirt, bring your full rescue pack, helmet and gloves, and prepare like you would for a mission without knowing the conditions of the terrain you may be up against. If you have personal tech gear such as a harness, carabiners, etc., please bring them too (if not already part of your standard kit).

TRACKING

SARA will be hosting a joint training opportunity with Mohave County SAR on Saturday, April 20 at 08:00. The topic of the training will be tracking in accordance with the ASARCA Taskbooks. For those unaware, Mohave County is the fifth largest county in the contiguous United States and offers a very diverse topography and climate. This is a unique opportunity to learn from experts in tracking in all types of environments and develop the skills needed to satisfy the requirements of the taskbook so we can further our own capabilities as a team both locally and in mutual aid applications. Currently, the extent of SARA's tracking curriculum aligns with the level one taskbook and is taught during AZ Basic.

This training will serve two purposes:

1. Learning skills from levels II and III of the ASARCA taskbook

2. Certifying those who complete both levels and wish to become instructor/evaluators for the purpose of educating and certifying other members of your component organization in the future.

TECHNICAL SKILLS: CLUTCH TASK BOOK SUPPLEMENT by Richard Hounshell, richard.hounshell@sarci.org

The Board has approved a Clutch Task Book Supplement that will be used to bridge the gap between the retirement of the MPD and implementation of the Clutch. The supplement can be completed without needing to complete a new task book. As with our existent task book, you can complete the supplement as either Awareness, Operations, or Technician as appropriate for your current level (or lower if desired). It is important to note that to remain Field Qualified, all members must complete this Clutch task book supplement by July 1, 2024. If you complete a Clutch supplement at a lower level than your current task book, on 7/1/2024 you will revert to that lower level of task book. Signoffs for the supplement will be available at all applicable technical trainings just as they are with MPD signoffs. We hope that you will work towards completing this expeditiously, so that we can begin the transition away from the MPD as soon as possible.

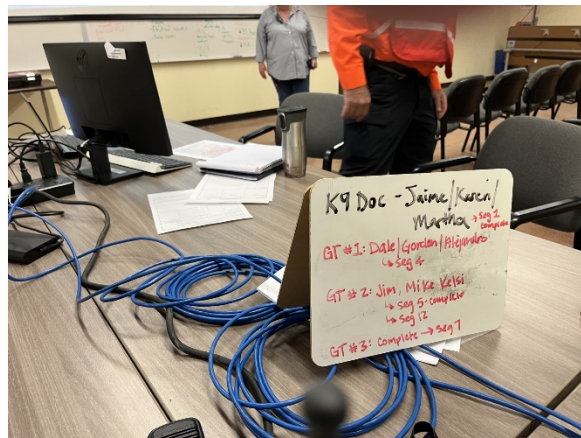

IMT PLANNING SECTION - EXERCISE SUMMARY

The SARA IMT Planning Section designed a search exercise as though an individual had gone missing during a hike from Hitchcock Campground the night before. Starting with a report from the initial response an Incident Action Plan was developed. The training was run as though it were an actual operation. Clues were planted ahead of time in segments that had been drawn and prioritized. Teams were assigned the night before based upon responses to a training email. On the morning of, team members reported to the SARA House at 06:00 for check in and briefing (and team reorganization based upon turnout). Teams left for the field around 07:00 and Ops was set up in the vicinity of the campground. Incident Command Post (ICP) remained at the SARA House and is pictured in the photos. Upon completion of their assignments, teams returned to the ICP for check out and debriefing. Teams were officially demobilized following debriefing. Once all teams were debriefed a planning meeting was held to work on a plan for the following operational period.

- 1: Debrief of a team by SAMSAR members Mike and Chris Massimi.
- 2: Team assignments in front of the WinCasie operator on the Situation Leader (SITL) table
- 3: Overview of SITL table. Joe Barr: *Planning Section Chief*, Mike Massimi: *Debrief*, Kim Childress: *WinCasie*, Sara Truebe: *SITL*, Tracy Klopp: *Communications*.
- 4: as 3rd photo w/map on screen, Deputies Chris and Steve, and Chris Yamanaka: *IC*.

Wed Feb 07 10/ 50/ ??ym hiker missing Picacho Peak PinalSO PinalSAR M3T M30T
No field times A male hiker was missing from a hike to the peak on Tuesday. On Wednesday, Pinal resources looked by air and ground and accumulated information from other hikers. The drone team was requested during the afternoon: one flew from the front side and one from the back side. The area below the peak on the front side was of primary interest for the aircraft, and the hiker was spotted within an hour, deceased.

Thu Feb 08 16/ 108/ ??ym hiker recovery Picacho Peak PinalSO PinalSAR
 12:20 – 15:40 In the morning, a recovery was attempted by the Pinal helicopter. They inserted several rescue specialists (RS) but were unable to retrieve the subject by hoist due to weather conditions. Ground teams were requested and the recovery was made.

Mon Feb 19 13/ 26/ 2 30ym hikers off trail Romero Canyon, Catalinas
 18:30 – 18:45 Two hikers requested help after getting off trail upstream of Romero Pools. While we responded, they found the trail, and the first team met them near the trailhead.

Tue Mar 05 11/ 64/ 56ym hiker ankle injury Butterfly Trail, Catalinas RMFD MLFD
 10:10 – 13:05 The Butterfly Trail was covered by packed snow and a hiker injured his ankle. He was carried out by litter.

Mon Mar 11 17/ 33/ ??yf hiker ankle injury x7 Bear Canyon, Catalinas RMFD
 17:50 – 18:15 The Hasty Team did not find any injuries on the trail. Two calls in Bear Canyon may have been handled by Rural Fire.

Tue Mar 12 17/ 90/ 55yf climber ankle injury Jailhouse Rock, Catalinas Ranger1 RMFD
 15:15 – 18:45 A climber fell and injured an ankle. Rope systems were set up, but Ranger1 (from Phoenix) hoisted her.

Sat Mar 16 30/ 139/ 32yf canyoneer fall injury Canyon del Salto, Catalinas Ranger2 RMFD
 12:15 – 14:35 A canyoneer slipped and fell before her team had rigged the first rappel. Teams packaged her part way down the first drop, in very limited space, and Ranger2 hoisted her.

Tue Mar 19 17/ 42/ 12ym hiker ankle injury 7 Falls, Bear Canyon, Catalinas Ranger2 RMFD
 16:10 – 17:25 A group from Phoenix was at 7 Falls when one slid and injured an ankle. They got him to the base of the falls and Ranger2 picked him up and took him to the Overlook LZ.

Tue Mar 26 6/ 16/ 30ym missing Avra Valley M3T M30T
No field times A homeless person had been recruited by a weed eradication crew working in the eastern foothills of the Silverbell Mtns. On his second day he became separated from his teammate and was lost. As drone teams arrived at the search, Deputy Raterink found him at the Gas Line.
