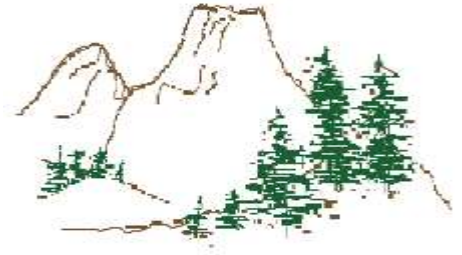

### **NEW TRAINING REQUIREMENTS**

This is a reminder of some training requirements that will go into effect soon:

**Bloodborne Pathogens** Awareness training - needs to be done annually. Check your status on the SARCI Field Qual Report (available on the SARCI Data page) in the "BBP" column. It shows the year and month (YYMM) that your training expires.

If you need this training, contact your team leadership.

**AZBasicSAR** – must have been done after 2012. Check your status on the SARCI Field Qual Report in the "AZ Basic" Column. If this field is shaded yellow you must take a current version of this training.

If you need this 16 hour training, advise Records of your availability so we can schedule at appropriate times.

Sometime over the next few months these will formally become SARCI Field Qualification requirements. Don't delay!

**SARA TRAINING: Helicopter Ingress/Egress**

SARA will be conducting an ingress/egress helicopter training with DPS Ranger at 09:00 on March 17. Our most common interaction with DPS Ranger is being inserted or retrieved in the back country and is one of the most hazardous activities a SARA member will experience. The purpose of this training is to provide familiarization with the procedures for getting in and out of a running helicopter safely in varied terrain.

Due to space limitations this training is for field qualified and active candidates / members only. Participation will be limited to 15 individuals and an RSVP is required at: <http://whoozin.com/P94-H7N-3P3K>

All training participants will need the following: long sleeve shirt and long pants, both of a fire-resistant variety (cotton or wool), a helmet, boots, gloves, eye and ear protection and your rescue pack. In addition, previous attendance at a DPS static helicopter training or the SALT static helicopter training is a mandatory prerequisite. Please email me with any questions.

**SARA TRAINING: Tech Skills**

Evaluations for the Technical Skills Task Book may be done at the monthly general meeting or at any meeting, training, activity, or event to which the entire membership has been invited. This includes missions, although opportunities for sign-offs may be limited. A roster must be provided to Records with the names of all evaluators and of the Members being evaluated.

**SARA TRAINING: March/April**

The March training will be a continuation of the personal rope skills from last June. This time the emphasis will be on rope-climbing using Purcell Prusiks, since we have introduced rappelling previously. Required equipment will be helmet, gloves, a commercially-sewn seat harness, a chest harness, webbing to connect those two, and several carabiners. You also need a set of Purcell Prusiks that is sized to you (a long and a medium foot Purcell Prusik and two regular short Prusiks).

Meet at 106 no later than 08:00 on Saturday, March 3.

The training for April will be a two-day class on swift water rescue, which will be taught by personnel from Rural/Metro. It will be on April 21-22; both days are required. Rendezvous location and time will be announced later. On completion of this class, you will be eligible for a Swiftwater I certification from the Arizona Center for Fire Service Excellence (ACFSE). The certification is \$25 (not reimbursed by SARA) and requires course registration with ACFSE; details will follow.

The first part of day one is classroom PPT. The remainder of the day is at the pool and consists of a 300-meter swim with a PFD (personal flotation device) AND a 300-meter swim without a PFD. You don't have to be an accomplished swimmer, but you must do this. The remainder of the pool session is treading water, entries, patient approach/escape, throw bags, etc.

Required equipment for the two-day training will be helmet, gloves, shoes or boots, and a PFD. SARA will supply a few PFDs from the truck equipment. You may rent or borrow a shorty wet/dry suit for the river portion of the class, since the water will be cold.

The class is limited to 18 people, and there is a Whoozin sign-up at <http://whoozin.com/R64-7EH-DGQG>. If more than 18 people respond, priority will be given to those Candidates or Rescuers who are field-qualified and who are currently active on missions.

13:40 – 16:20 A hiker injured her ankle about 1.5 miles up canyon. She was packaged and carried out by stokes.
- Sun Jan 28 17/ 66/ 34ym hiker ankle injury TV Main Falls, Rincons TucsonRanger RMFD**  
13:55 – 15:40 A hiker injured his ankle at the Main Falls on a windy day. Tucson Ranger landed on the beach and ferried the patient to the road.
- Tue Jan 30 7/ 19/ ??y? mtn bike down 50 Year Trail area, Catalinas GRFD**  
No field times A bike rider crashed just south of the Catalina State Park boundary, complaining about a hip and other injuries. A Golder Ranch UTV got close, and the patient was packaged and carried the short distance.
- Sat Feb 03 20/ 77/ 36yf hiker leg injury Blackett's Ridge Trail, Catalinas RMFD**  
15:05 – 17:10 A hiker coming down-trail injured her ankle. She was carried by stokes to the trailhead.
- Sun Feb 11 11/ 12/ ??yf hiker exhausted Sabino Lake Trail, Catalinas RMFD**  
No field times A hiker was exhausted and didn't know how to get down to the roadway from a parallel trail. It sounded like more assistance would be needed, but Rural Fire medics got down to the road easily.
- Thu Feb 15 11/ 27/ 65ym runner stranded x7, Sabino Canyon, Catalinas RMFD**  
No field times A runner returning from the end of the road was caught by floodwater. He waded a couple of bridges, then was washed off the road and downstream until he was able to crawl onto a rock. Several other walkers were stranded elsewhere. All but the first one were retrieved, and he required assistance to wade out.
