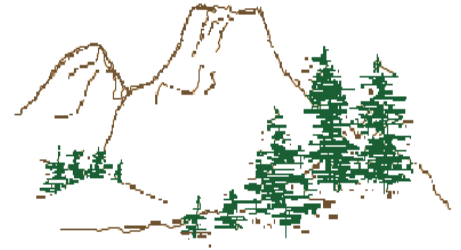

SABINO CANYON PARKING

NEW TRAINING REQUIREMENTS

This is a reminder of some training requirements that will go into effect soon:

Bloodborne Pathogens Awareness training - needs to be done annually. Check your status on the SARCI Field Qual Report (available on the SARCI Data page) in the “BBP” column. It shows the year and month (YYMM) that your training expires.

If you need this training, contact your team leadership.

AZBasicSAR – must have been done after 2012. Check your status on the SARCI Field Qual Report in the “AZ Basic” Column. If this field is shaded yellow you must take a current version of this training.

If you need this 16 hour training, advise Records of your availability so we can schedule at appropriate times.

Sometime over the next few months these will formally become SARCI Field Qualification requirements. Don't delay!

SRDI is proud to recognize K9 Dexter/Mike Wilke and K9 Archie/Karen Paquette for their part in concluding a recent search.

Congratulations to Mike Wilke/K9 Dexter and Mark Paquette/K9 Archie on successfully achieving the new SRDI Air Scent Level 2 certification! This certification is conducted at night, is 60-80 acres, encompasses at least three search areas, includes one blank area, and includes 0-3 subjects which can be in an enclosed location (tent, sleeping bag, culvert pipe, etc.) Many thanks to Cochise County Handler, Patti Klawans, for acting as our subject and for serving as an outside evaluator for this certification.

SRDI's team goal of 100% compliance with Scientific Working Group on Dog and Orthogonal Detector Guidelines (SWGDOG) continues. SWGDOG SC5.4 Obedience & SC5.16 Character Traits, will be conducted following the SRDI Monthly Meeting on May 6; SC5.7 Search Techniques and SC5.17 Properties of Scent will be addressed May 12 at Empire Ranch. We are designing Handler Training curriculum in compliance with SWGDOG classroom requirements for dog handlers. We are also aligning our discipline proficiency assessments to meet both ASARCA and SWGDOG specifications. Next on our agenda is updating our standard operating procedures.

A forest volunteer accompanied her down trail until meeting Rural Fire, a SAR Officer and volunteer teams. All continued without problems, down the Link Trail to the road.

 10:30 – 11:50 A hiker injured her ankle between the top of the switchbacks and the top of the Historic Trail. She was carried out.

 06:20 – 09:05 A male was reported missing. The next day his car was found at the trailhead and a limited search was completed before dark. The next morning resources were staging and planning team assignments. A canine team had started early and located the subject deceased a short distance up a drainage. A team assisted with the evacuation.

 00:35 – 01:55 A hiker was affected by a recent change in meds, and was returning from the summit when he was unable to continue from a short distance above the spring. He was rehydrated and was then able to walk out.
